AN ORDINANCE OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AUTHORIZING THE SALE OF A 2004 CHEVROLET IMPALA OWNED BY THE VILLAGE OF CHAPIN, ILLINOIS

WHEREAS, the Corporate Authorities find that it is no longer necessary or useful to or for the best interests of the Village of Chapin, Illinois, to retain ownership of a used 2004 Chevrolet Impala; and

WHEREAS, the Corporate Authorities determine that it was in the best interests of the Village of Chapin to sell the personal property.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the President and Board of Trustees find that the used 2004 Chevrolet Impala, now owned by the Village of Chapin, is no longer necessary or useful to the Village and the best interests of the Village will be served by its sale.

SECTION 2: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the Village President is directed to take all necessary action to sell the vehicle. The Village President may, if he so elects, seek sealed bids for the sale of the vehicle and accept the bid which, in his opinion, is in the best interests of the Village.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
