

ORDINANCE NO. 4
SERIES 1978

AN ORDINANCE AUTHORIZING THE TOWN OF MARBLE, COLORADO TO VOLUNTARILY EXTEND SOCIAL SECURITY COVERAGE TO ITS ELIGIBLE EMPLOYEES, AND TO ENTER INTO AN AGREEMENT FOR THAT PURPOSE WITH THE COLORADO DIVISION OF EMPLOYMENT.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MARBLE:

As the 38th General Assembly of the State of Colorado, in regular session, enacted Chapter 237, 1951 Session Laws, (now known as 24-51-701 to 710, C.R.S. 1973, as amended) to enable political subdivisions of the State to voluntarily take all action necessary to effectuate coverage of certain officers and employees under the old-age, survivors, disability, and health insurance system pursuant to Section 218 of Title II of the Federal Social Security Act, as amended; and, as the Division of Employment and Training of the Department of Labor and Employment is the designated authority to implement and administer the State's Public Employees' Social Security Retirement system to provide for the coverage of certain officers and employees under the said old-age, survivors, disability, and health insurance system; be it ordained by the Town Council of the Town of Marble that it is the considered opinion of this body that the extension of the Social Security system to certain officers and employees of the Town of Marble will be of great benefit, not only to the employees of the Town of Marble by providing that certain officers and employees may participate in the old-age, survivors, disability, and health insurance system, but will also be of great benefit by enabling it to attract and retain in employment the best of the personnel and thus increase the efficiency of its government.

The Treasurer of the Town of Marble is hereby authorized to execute and deliver to the Division of Employment and Training, this ordinance and a State-Local agreement, required under Section 704 of said enabling Act and the Social Security Act, to extend coverage to certain officers and employees of the Town of Marble and do all other things to effectuate coverage of certain officers and employees under the old-age, survivors, disability, and health insurance system.

The Treasurer is hereby authorized to establish a system of payroll deductions to be matched by payments by the Town of Marble to be paid into the Colorado social security contribution fund through the Division of Employment and Training, and to make charges of this cost to the fund, or funds, from which wage or salary payments are issued to employees of the Town of Marble. Such payments are to be made in accordance with the provisions of the Federal Insurance Contributions Act on all services which constitute employment within the meaning of that Act. Payments made to the Division of Employment and Training shall be due and payable as the Division may require, and such payments which are delinquent shall bear interest as provided under 24-51-704, C.R.S. 1973, as amended, Social Security Fund, until such time as payments due are made.

Appropriation is hereby made from the Social Security Fund, of the Town of Marble in the required amount to pay into the Colorado social security contribution fund as provided in section 24-51-704 (3)(a) of the enabling Act and in accordance with this ordinance and the State-Local Agreement.

Authority is hereby given to the Mayor of the Town of Marble to enter into an agreement with the Division of Employment, which agreement shall be in accordance with 24-51-701 to 710, C.R.S. 1973, as amended, and with Section 218 of Title II of the Social Security Act. This ordinance and the State-Local agreement shall provide that the participation of this Town of Marble shall be effective on July 1, 1977.
