

SPECIAL CALLED MEETING CANVASSING OF ELECTION VOTES OF THE MUNICIPAL ELECTION SEPTEMBER 1, 2020

The Town Council met September 1, 2020 at 6:00 p.m. in the Thorsby Municipal Annex Building.

Mayor Hight called the meeting to order at 1:00p.m. Mayor Hight gave the invocation.

Council Member Benson moved to approve that the Provisional Box was sealed and there were 4 Provisional Ballots to be counted and that Chilton County Board of Registrars certified that only 2 of the 4 ballot(s) should be counted. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Benson, Crumpton, and Chapman.

Council Member Littleton moved to approve and certify the official canvass of the votes cast in the general Municipal Election held in the Town of Thorsby on August 25, 2020 shows that Chasity Cleckler Chapman was duly elected to Seat #2 for the term commencing on the first Monday of November, 2020 Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Benson, and Crumpton. Abstained: Chapman

Council Member Chapman moved to approve and certify the official canvass of the votes cast in the general Municipal Election held in the Town of Thorsby on August 25, 2020 shows that Justin Killingsworth was duly elected to Seat #3 for the term commencing on the first Monday of November, 2020 Council Member Benson seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Benson, Chapman, and Crumpton.

Council Member Littleton moved to approve and certify the official canvass of the votes cast in the general Municipal Election held in the Town of Thorsby on August 25, 2020 shows that Marvin O. Crumpton was duly elected to Seat #4 for the term commencing on the first Monday of November, 2020 Council Member Chapman seconded the motion.
