# Criminal Law Forensic Summit 2018

*Featuring Dr. Itiel Dror—World-Renowned Expert in Cognitive Bias*

An expert in conducting cell phone searches demonstrates how a search is done, and then a panel—featuring experienced attorneys in both the defense and prosecution bars and a judge—discusses the legal and strategic issues that arise in cases involving cell phone searches. The cell phone panel covers language in cell phone warrants and the substantive and procedural requirements of *Gelfatt* motions, seeking to compel unlocking of cell phones.
