I am not aware of any secret meetings about students, however I did receive a FOI request from Special Agent Danny Kelly on June 3, 2022, John Hardy replied to this request on June 8<sup>th</sup>, 2022. The response included the following, "You have requested the recordings and the certified agendas of the closed session board discussions that reference our situation. ...

Under the Texas Open Meetings Act, any recording or certified agenda of a closed session meeting of the District Board of Trustees is confidential by statute, and is not available for public release or inspection, Indeed, the law is so well settled on this issue, that the Texas Attorney general has issued a prior determination that those records do not need to be submitted to the Office of the Attorney General for a ruling – the District is automatically permitted to withhold records. ## Dollars and Sense

According to the WISD financial rating and the WISD posted minutes, our school district is in short supply of both.

On November 16, 2021, an agenda item read as follows:

7.F. Consider/Action on the Request to Hire Johnson & Pace, Inc. to Design a Future Meat Processing Educational Lab Facility.

During that "consider" portion of the meeting, two of the WISD board members conveyed their concerns with the future meat processing facility and spoke out, as a board member should, about their concerns and other priorities of the district. Shortly after that discussion, the agenda item was tabled till further discussion could be had.

As reported in the WinnsboroNews.com on November 16, 2021, the following information is attributed to the WISD Superintendent:

Superintendent Dave Wilcox apologized to the architect for wasting his time and said he would not waste his time again. Wilcox said he had entered the pursuit of a design architect with the understanding that all the board members favored the proposal and had heard no opposition until the Monday night meeting.

The information pertaining to the November 16, 2021 agenda item regarding the meat lab is accurate. I was irritated after being lied to again by one of our board members at the time. Below is an excerpt from the email I received on the night of November 16<sup>th</sup> from Joey Keef and an excerpt from a 2<sup>nd</sup> email received from Mr. Keef the same day prior to the meeting,

Mr. Wilcox,

After much thought and consideration I will not be posting anything on FB tonight. I do feel that the situation could have been handled alot differently without creating division in our community. It has ZERO to do with what XXXXX said, but 100% to do with how it was handled was my issue. Therefore if I were to post something it would only be creating more division and this is not my desire for our community.

Although I still stand by my decision to put the meat lab on hold, I owe you an apology for not letting you know my feelings sooner. That is what has eat at me today. I looked you in the eye last Friday and told you I would always come to you first, no surprises. Last night, I did not hold my end of the bargain. I sincerely apologize for doing that to you. I should have let you know last Friday of my stance. Again, I apologize.

On behalf of WISD, we would like to apologize for the language that was used by a community member, who is not an employee or representative of WISD, during last night's public forum portion of the WISD Board Meeting. The language used was offensive and in no way represents the culture of WISD.

The Administration should have acknowledged the vulgarity and addressed it at that time. This kind of language is not acceptable in any capacity or circumstance and again we would like to apologize and assure you that this will not be tolerated.

You and I both know this is misleading at the very least and slanderous at the very worst. Our District is above these standards and we want to promote unity within our community. Actions like these do nothing but divide and tear down. People in the community, from what I can gather, are assuming this statement is a direct reflection on not just administrators, but the WISD Board as well. I firmly believe in transparency and standing for truth, no matter the outcome. If you refuse to rescind the above statement by midnight tonight, I will be forced to post something on Facebook on behalf of myself only, not the entire Board, sharing exactly what happened in that meeting last night pertaining to XXXXXX remarks.

**The rules are in place for good reason....you do not supervise family, friends, or business partners for this very reason....and NO, it's a small town does not hold up in the court of public opinion, or court of law.**

### **Answer:**

During one of Special Agent Danny Kelly's public forum speeches he stated the following, "I'm concerned the relationship of the stepfather with the athletic director and the Superintendent is a contributing factor to the minimal response we have received to this situation. Furthermore, I respectfully request that the board inquire as to any business relationships between the Superintendent and the Athletic Director that may be prohibitive to the oversight of our athletic programs.

Ultimately, Mr. Kelly's statements during public comment of the Winnsboro ISD Board meeting and his submission of Ms. Kelly's email to the WISD board prompted a complaint by parents of another child in the district.

WISD retained Marianna McGowan with Abernathy, Roeder, Boyd & Hullett, P.C. to provide assistance with an independent investigation regarding allegations raised by the parents of the other child. The district retained the firm to interview the complainants, subjects of the complaints, and relevant witnesses identified in the course of the investigation and provide a written analysis of the findings. Although the district could have hired a non-attorney investigator, or could have assigned an internal employee to conduct the investigation, the district chose to retain the firm in this capacity to benefit from the special legal knowledge.

Ms. McGowan was also asked to investigate the conflict of interest claims made by Danny Kelly. Included below is her findings:

The Kelly's raised two areas in which they felt Mr. Wilcox and or Mr. Finney, had a conflict of interest in this matter. The first conflict of interest they mentioned was that Mr. Wilcox's adult daughter was dating the adult son of the other family. While their adult children may date, it does not have an impact on the campus level. The second conflict of interest reported by Ms. Kelly was that Mr. Wilcox shares land with Mr. Finney. Mr. Wilcox and Mr. Finney shared in their interviews that they do have cows and in the same pasture and they take turns buying feed and splitting cost. While they may share the same pasture, there is no evidence this would cause a conflict of interest. The Kelly's therefore provided no direct evidence to support their conflict of interest claim.

The website makes several digs at Taylor Huffman.

Answer:

All of coach Huffman's supervisors have a strong opinion of him. In fact, I have only heard complaints about him from the Kelly's and emails from Brett Burnett requesting that I reassign Taylor. Below is an excerpt from an email from Brett Burnett dated December 9, 2020.

*Good morning, Mr. Wilcox. I am emailing this morning to voice my concern for the future of boys basketball in Winnsboro.....What is obviously clear to me and many others is that our current Varsity coach and his team of coaches just do not belong as boys basketball coaches. Coach McAfee is my neighbor, and I taught both Bosold and Huffman when I was a high school math teacher, so this is nothing personal against any of those guys....Boys basketball has been a huge JOKE in Winnsboro since I was in high school here in the mid 1990s. I believe with our new high school, a very impressive new superintendent and staff, now is the time to turn that terrible reputation that boys basketball has in Winnsboro around. I urge you, if you haven't already, to strongly consider a change.....Again, thank you for serving here in Winnsboro. Your presence is already positively affecting our community and school and look forward to see what the future holds for Winnsboro ISD.*

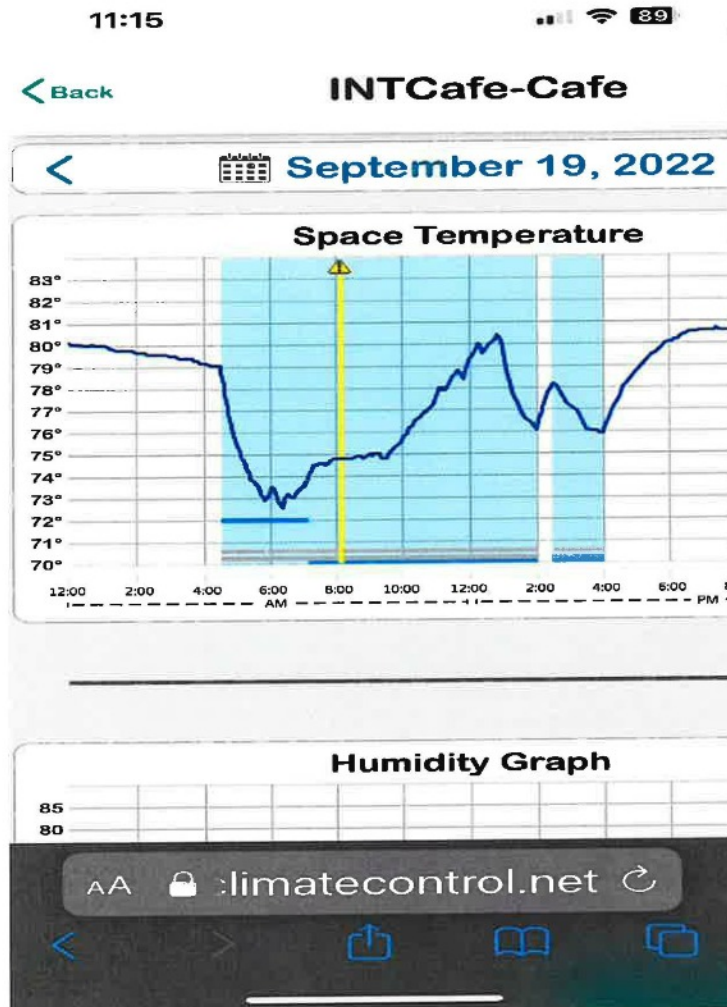

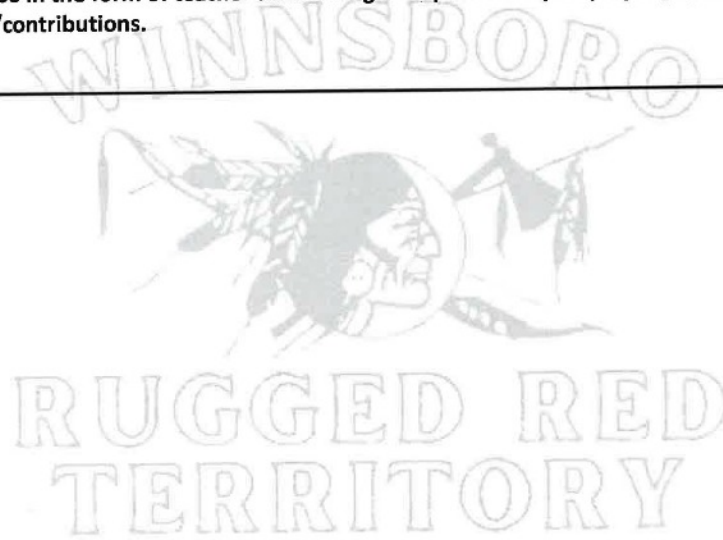

In my years as working as an accountant I had never encountered an organization with the number of issues that were identified at WISD. Weak internal controls can include anything that creates a risk of financial reporting misstatements – this can include error, fraud, theft, etc. These issues have existed for years at WISD. They were never identified in the audit reports completed by the previous auditors.

Some examples of internal control issues at WISD include:

- Bank accounts not reconciled for a year
- 40+ credit cards issued to employees who made purchases without approved purchase orders (this violates TEA policy, numerous statutes, policies, legal interpretations and procedures for the State of Texas and the Federal government)
- electronic requisitions/purchase orders implemented January 2020 by Dave Wilcox (prior approval of purchases not documented previously)
- No documentation supporting employees' pay
- Segregation of duties did not exist – employees in the Business Office could complete all steps of the accounting process without oversight
- Fixed assets not maintained in a current electronic system
- Compensation Plan did not exist; employees' pay was decided on an individual basis with no documented process as to how the amount was decided
- Global access in accounting system was granted to individuals that did not have a business need for the access

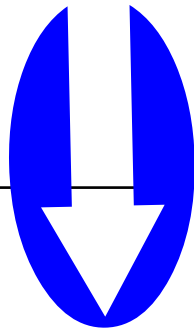

On July 18, 2023, TCR received a text message, “Just curious if you have seen this website? Therealwisdcom?” (Actually, no, not at that time.) Since that date, I’ve looked at the content, and looked at the content less and less; however, there are some factual observations to present to the public and to the anonymous participants behind the website, for consideration and accountability.

TheRealWISD domain name was purchased through GoDaddy (called a domain host) on June 23, 2023. The registrant The registrant then cloaked their name by paying for a private registration; this called privacy domain name registration. In the Internet world, many domain name owners do this privacy to reduce unwanted contact and mail from solicitors, hackers, loan sharks, spammers, etc., or for other reasons.

TheRealWISD began posting blogs sometime the first week of July 2023. The person or people behind the website have stated they wish to remain anonymous. As an opinion editorial, it is probably because the person(s) fear retaliation or retribution. Someone, or group of someones, certainly have a burr in their saddle over a sundry list of topics.

While they blog about transparency, they work behind a dark veil of not only anonymity, but inaccuracies and apparent bitterness for unresolved anger or conflict resolution skills. Maybe this public information and research will begin to pierce the veil, and bring people to the table of peacemaking and fruits of the spirit, and not works and sins of the flesh.

## **Point 1.**

To present oneself with a domain as a “REAL” government entity could be considered a crime under state And federal laws. The site is certainly not set up as satire. To use the name “Real” is blatantly misleading and runs the risk of damaging the district and community image for people who may not know it is NOT authorized, nor the “real” site.

## **Point 2.**

The site uses the logos of the Texas Education Agency. Without a written contract for license for use, This is a violation of LAW and punishable under TEXAS STATE LOCAL GOVERNMENT CODE, quoted:

TITLE 10. GENERAL GOVERNMENT  
SUBTITLE B. INFORMATION AND PLANNING  
CHAPTER 2054. INFORMATION RESOURCES  
SUBCHAPTER A. GENERAL PROVISIONS

(9) "Local government" means a county, municipality, special district, school district, junior college district, or other political subdivision of the state.

Sec. 2054.263. SEAL. The department shall adopt an icon, symbol, brand, seal, or other identifying device to represent the project.

Sec. 2054.269. INTELLECTUAL PROPERTY RIGHTS. The department may exercise all intellectual property rights regarding the project, including prevention of other persons from using names or designs similar to those used by the project to market products. ## **Point 3.**

The site uses the “Running W” logo of the University of Wisconsin. If it is *without a written contract for license for use of intellectual property*, and certainly not satire, according to research, experience and training, such practice is a violation of LAW and punishable under the Copyright Law of the United States (Title 17) and Related Laws Contained in Title 17 of the United States Code (<https://copyright.gov/> and <https://www.copyright.gov/title17/>). “Statutory damages are usually between \$750 and \$30,000 per work, as determined by the court. However, the damage amount can be increased up to \$150,000 per work if the infringement is found to be wilful (intentional).” In fact, criminal copyright infringement charges can result in prison convictions under federal laws.

The University of Wisconsin has proven to take copyright offenders to legal task in the past, as shown in Google searches and legal research.

**Point 4.** Trails Country Reporter has verified that on “TheRealWISD” site, the image of the WISD school board of trustees was actually lifted (taken) from a website called “Wood County Now” as verified by an owner, and used without permission for use (copyright violation). In other words, plain English, stolen intellectual property. It’s not a victimless crime. The government just doesn’t make laws for the fun of it. It’s when people don’t behave and take things that don’t belong to them, even digital intellectual PROPERTY, or people do things they shouldn’t do. It’s not only about law, but ethics and morality.

**Point 5.** The “Real” site is certainly not compiled with journalistic skill, conventions or styles. It’s riddled with grammar and punctuation errors, and its difficult to tell where they blog begins and ends and where quoted material begins or ends. It also lacks references and proper citation for materials throughout the entire website. *Vetting the work and citing sources is critical in the integrity of journalism.* An example is an ink well with a blog on the site, and the words, “There Dave, I fixed it for you!” Is the passage above it by Dave Wilcox? When? How? Email? Who knows? It should be something like, “Mr. Wilcox, I updated the content of your letter to us on [date].” T The site talks about Bullying, yet bully’s students for their social media posts. The site talks about transparency but is not. The site itself is named as a fake, fraud, misleading “Real.”

**Point 6.** This “Real” not real site point problems with little “come to the table, let’s chat over coffee and be peacemaker” resolutions. The structure is in place at school districts across our state, and if talking to people one one one, FIRST, doesn’t work, there’s the public input at meetings. IF that doesn’t work, there’s the polling both and elections. There’s letters to the editor. And there’s running away or giving up and not addressing the conflicts.

**Point 7.** So, it is pretty interesting the site “screams” of ethics and transparency, and here they are, violating state and federal laws to get their points across. What you are doing, speaks so loudly, in how you are doing it, its difficult to hear a thing they say with their written words. Experience means more to the public than written words.

The experience of the Winnsboro area public is sometimes reeking of discord and arguing, with folks taking sides and making unvetted accusations, unresolved conflict: it just NEEDS TO STOP. The children, the students are watching the adults. The time the administration looks at this site, which probably less and less, takes away from the core focus of education and the students and caring for the districts wonderful faculty and support teams. Resolve conflict peaceably.

In case folks have forgotten the true struggle, I’ll close with a list on the final page of this op ed. I’ve learned the hard way to NOT be a flag bearer, a torch, or fuel flaming the fire of public controversies. Just please stop it, and go to people one-on-one and try to resolve differences. Then vote. If God’s in you, and God’s in them, God gets along with God, then what’s the problem. Yes, even Christians disagree. And Good people. Let’s fine unity. Thank you for your time.
