## **MINUTES**

The regular meeting of the Village of Innsbrook Board of Trustees was held on Tuesday, February 13, 2024, at Village Hall, 1835 Highway F, Innsbrook, Missouri, in person, and via Zoom Video Conference. The meeting was called to order at 5:00 PM (CST) with Chairman Reuter presiding. Chairman Reuter led the Pledge of Allegiance.

Upon roll call, Trustees Cynthia Cook, Mike Lyles, Dan Reuter, John Simon via Zoom and Donna West were present, establishing a quorum. Others in attendance included Village Administrator/Clerk - Carla Ayala, Village Planner – Todd Streiler, Nathan Bruns – Hesse Graville, Mike Caton – Wags and Whiskers, Tracy Dickherber – Innsbrook Corporation Activities Coordinator, Allen Huddleston, and various residents in person and via videoconference.

#### ADOPTION OF AGENDA AND APPROVAL OF CONSENT CALENDAR\*

Motioned by Trustee West, seconded by Trustee Lyles, to adopt the agenda and to approve the consent calendar. Chairman Reuter yielded the floor for debate, but no debate was held. By voice vote, all Trustees present voted "Aye". The motion passed and was approved with a 5 "Aye", 0 "No", 0 Abstain vote.

#### APPROVAL OF MINUTES

## CHAIRMAN'S REPORT/APPOINTMENTS

Chairman Reuter reported that he spoke to the head of security at Innsbrook Corporation, and would like for him to attend a future meeting. Trustee Cook and Chairman Reuter met with Tracy Sator, Mike and Kathy Caton to discuss issues with Wags and Whiskers.

## **DEPARTMENT REPORTS**

- a. \*Financial Report/Bills of the Month: The January 2024 financial report and bills of the month were approved on the consent calendar.
- b. Administrator's Report: The report of the Administrator was received and placed on file.
- c. University of Missouri Extension Council Report: Mr. Virgal Woolfolk was not present.
- d. Planning and Zoning Commission Report: Mr. Alen Huddleston reported that the Planning and Zoning Commission recommend to the Board of Trustees that the change to Wags and Whiskers site plan is a major change.
  - i. Village Planner Report: Todd Streiler explained to the Board of Trustees the difference between a minor and major change according to the Village regulations. Following this, Todd Streiler reported that the Planning and Zoning Commission held a work session on January 18, 2024 for the Comprehensive Plan Kick-off. The hope is to have a revised Comprehensive plan in ten to twelve months.
- e. Village Administration Building Committee Report Trustee Cook mentioned that the Committee has not met; however, Trustee Lyles contacted the Missouri Department of Natural Resources (DNR) and Cochran regarding the existing well on the Village Property. Trustee Lyles stated that DNR was mistaken on who owns and operates the public water supply, the Village or Innsbrook Corporation. The resorts public water supply is not owned or operated by the Village, therefore the current well on the property can be used for the new Village Administration Building, if it is in working order.
  - i. Soil Boring and Septic Testing Reports Cochran performed a soils test for the on-site septic system for the future building. The report shows that an underground drip system can be installed on the site, per the layout of the Site Plan.

#### **UNFINISHED BUSINESS:**

a. RESOLUTION NO. 2024-1 - A RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF INNSBROOK, MISSOURI AUTHORIZING DESTRUCTION OF CERTAIN VILLAGE RECORDS IN ACCORDANCE WITH STATE LAW REQUIREMENTS:

Trustee Cook expressed concern about retaining accounting records for at least seven years. Trustee Cook will redraft the resolution removing necessary items to present at next month's meeting.

Chairman Reuter yielded the floor for debate, but no debate was held. By voice vote, all Trustees present voted "Aye". The motion passed and was approved with a 5 "Aye", 0 "No", 0 Abstain vote.
  - ii. Innsbrook Resort July 4th Celebration Fireworks; 07/06/2024; 9:15-10:00pm: Motioned by Trustee Cook, seconded by Trustee Lyles, to approve the July 4th Celebration Fireworks noise exemption with conditions. Chairman Reuter yielded the floor for debate, but no debate was held. By voice vote, all Trustees present voted "Aye". The motion passed and was approved with a 5 "Aye", 0 "No", 0 Abstain vote.

- Innsbrook Resort 2024 Summer Breeze Concert Series; 5/26, 6/01, 6/08, 6/15, 6/22, 6/29, 7/05, 7/13, 7/20, 7/27, 8/03, 8/10, 8/17, 8/24, 8/31; 7:30-10:00pm: Motioned by Trustee Cook, seconded by Trustee Lyles, to approve the 2024 Summer Breeze Concert Series noise exemption with conditions. Chairman Reuter yielded the floor for debate, but no debate was held. By voice vote, all Trustees present voted "Aye". The motion passed and was approved with a 5 "Aye", 0 "No", 0 Abstain vote.
- Innsbrook Resort New Years Eve Fireworks; 12/31/2024; 8:00-8:15pm: Motioned by Trustee Lyles, iv. seconded by Trustee Cook, to approve the New Years Eve Fireworks noise exemption with conditions. Chairman Reuter yielded the floor for debate, but no debate was held. By voice vote, all Trustees present voted "Aye". The motion passed and was approved with a 5 "Aye", 0 "No", 0 Abstain vote.
- b. Special Use Permit/Site Plan Amendment Wags and Whiskers; 13620 State Highway M
  - Zoning Regulation Section 14.9.7.1: Major and Minor Change Determination:

Motioned by Trustee West, seconded by Trustee Cook, the proposed amendments to the Wags and Whiskers Special Use Permit Site Plan are viewed as a major change. Chairman Reuter yielded the floor for debate, but no debate was held.

By roll call vote:

- Trustee Cook: "Aye"
  Trustee Reuter: "Aye"
  Trustee West: "Aye"
  Trustee Simon: "Aye"

The motion passed and was approved with a 5 "Ave", 0 "No", 0 Abstain vote.

- c. Cochran Proposal for Professional Services Village Administration Building: Motioned by Trustee Lyles, seconded by Trustee Cook, to postpone action on the Cochran contract until next month. Chairman Reuter vielded the floor for debate. Trustee Lyles requested time to look over the contract. By voice vote, all Trustees present voted "Aye". The motion passed and was approved with a 5 "Aye", 0 "No", 0 Abstain vote.
- d. Financing for Village Administration Building:

Motioned by Trustee West, seconded by Trustee Lyles, to withdraw the loan application with the USDA. Chairman Reuter yielded the floor for debate, but no debate was held. By roll call vote:

- Trustee Cook: "Aye" Trustee Reuter: "Aye" Trustee West: "Aye"
- Trustee Lyles: "Aye" Trustee Simon: "Aye"

The motion passed and was approved with a 5 "Aye", 0 "No", 0 Abstain vote.

Motioned by Trustee Cook, seconded by Trustee Lyles, to approve the terms of First State Community Bank for financing. Chairman Reuter yielded the floor for debate. Trustee Cook recommends that the Trustees approve the terms as outlined:

Option 1: 05/20 yr. term, 3 yr. non-call period, 20 yr. total, 5.75% fixed rate

Option 2: 10/20 yr. term, 5 yr. non-call period, 20 yr. total, 6.05% fixed rate

This would be to approve the terms only, not to approve a proposal with First State Community Bank. By voice vote, all Trustees present voted "Aye". The motion passed and was approved with a 5 "Aye", 0 "No", 0 Abstain vote.

e. Complaint - 15568 Walkers Way: Chairman Reuter spoke with the Village Attorney about the history of this property. There is still an issue on who owns the property. The Village Attorney offered to meet with the neighboring property owners to explain civil action. The Trustees did not want to incur the cost for the Village Attorney to do this. Chairman Reuter suggested that the property owners get state representatives involved.
