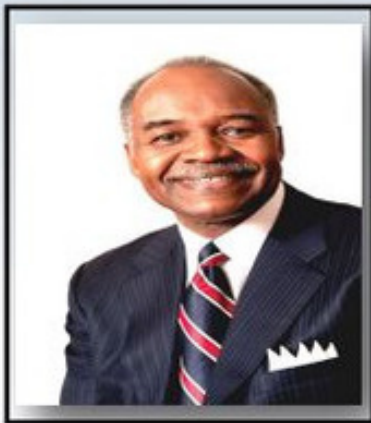

# **ANALYTICAL CURRICULUM VS CRITICAL RACE THEORY**

This memorandum is to recommend that an, "Analytical Imperative," be super-imposed upon all United States Public Schools Coursework. In turn, School Systems should discard inflammatory labels such as "Critical Race Theory." The goal of The Analytical Imperative would be the pursuit of either the highest truth, in The Arts; or, the most ethical and moral means in The Sciences. A brief explanation follows below.

# ANALYTICAL CURRICULUM VS CRITICAL RACE THEORY

A better foundation is The Analytical Imperative set forth above. Here we can teach students that the love of profit is the root of oppression. There is no real racial basis for this ultimate greed-lust. Hence, members of Meiners' own Caucasoid Race sent other Caucasians to fight wars, by way of The Draft, over the course of American History.

In New York City, early Irish immigrants were relegated to police department jobs. Early Italian immigrants were sharecroppers in large numbers. In practice, the superior ethnicity was a nation and not a Race. Known as WASPS, White Anglo-Saxon Protestants represented The British Empire (TBE.) As recently as last week the decline of TBE was in the news as Barbados is expected to declare independence from The British Crown in 2022. In closing, the ultimate question is what will today's students say of their education upon reaching maturity. Aside from the inflammatory nature of the label, Critical Race Theory, is it the best means to the truth? For all of the reasons set forth above, this author opts for The Analytical Imperative. What is the conduct of those in power, without regard to their Race?

# OPEN STATEMENT ON REDISTRICTING

Frederick Douglass once said, "There is no negro problem. The problem is whether The American People have enough loyalty, enough honor, and, enough patriotism to live up to their own constitution." Today, the issue is whether elected politicians have enough honor, loyalty and patriotism to live up to The Constitution they swore to obey. In 1870, The 15th Amendment was enacted, guaranteeing African- Americans the right to vote. For 151 years following The 15th Amendment, State and Local politicians have taken actions, sometimes violent, to deprive minority voters of their constitutional right to vote.

Ninety-five years after The 15th Amendment came the first federal statute designed to enforce the 15th Amendment. Known as The Voting Rights Act (VRA), this new law went beyond the mere reaffirmation of The Right To Vote for minorities. The VRA went forward to reject practices and policies which disenfranchised minorities through clandestine devices.

Still, in the wake of the first elections of minorities as the President and Vice-President of The United States of America, State and Local Governments have revived the backlash seen between Reconstruction and 1965. Specifically, these governments are adopting redistricting plans which limit minority influence in violation of The VRA. This dynamic is evident now in Baltimore County, Maryland.

In the context of The Post-2020 Census Redistricting Plans, The Baltimore County NAACP and The ACLU submitted their own joint, proposed plan.

# OPEN STATEMENT ON REDISTRICTING (cont)

This proposal offered The County the opportunity to expand the number of minority-majority County Voting Districts from one to two. This expansion is justified by the growing minority population in Baltimore County in 2021. Moreover, such a plan is required by The VRA when justified by existing population.

Still, The Baltimore County Redistricting Commission and The County Council enacted a different plan. The enacted plan “packs,” minority voters into one super-majority district. It then goes on to, “dilute,” the minority vote in the other current six councilmanic districts. In the face of apparent resistance, The NAACP-ACLU Alliance presented three additional proposals to The County Council without positive results. The Randallstown, Super-Majority District was created in 2001. The 20- year Interim has produced increased minority County-presence. Hence, this effort for proportionate Redistricting must be maintained. It is required by The VRA.

In closing, Former Congressman Newt Gingrich was once called his party, The Party Of Ideas! The spirit of this statement seems to be that the best ideas will combine with talent to win elections without regard to Race. The 89th Congress apparently shared this view when it passed The VRA.. We now offer this same chance to record a righteous constitutional advance, to The Baltimore County Council.

Hence, we encourage our members to participate in the upcoming redistricting sessions scheduled for December. Please see the next page for dates and additional information.

I was anxious about the appointment, hospitals are difficult places now, but per my cardiologist's orders I'm waiting for a stress test.

My name is called, down the hall to an exam room, behind the screens so ubiquitous in hospitals- my treadmill. He's very at ease, laughing, told me I didn't look 70, hooked me up, stepped me onto the treadmill, it started.

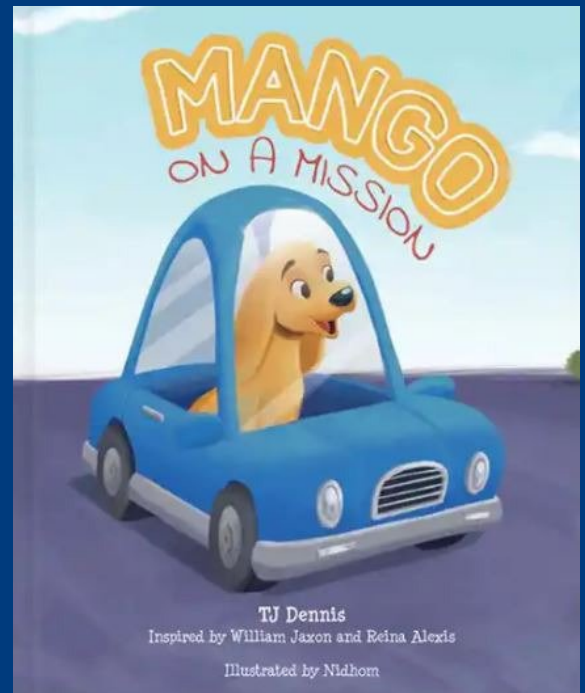
I read the collage of cartoons on the wall in front of me, jokes about stress. "You can stop this anytime you want. There's a mark we'd like you to make, it gets harder, but if you wanna stop it, say stop." Talking all the while he monitors the equipment, me, and the conversation. His wife's a teacher, teaching at home, now at school.

Covid. We talked about vaccinations, masks, we talked about roofs that needed fixing at my house, about art, my wife teaches art, all this.

"It's going to get faster." I focus to keep upright, now there's nothing but his voice and the treadmill. Then, he talks about anxiety, the resentment he feels treating so many unvaccinated patients, these last weeks brought him to that fatigue his profession was experiencing, he was experiencing it now, and the anger from a common sense response a to a worldwide epidemic unheeded. "That's it, it's over. You made it." The treadmill slowed, I cooled down. In minutes I'd be walking to the parking lot, heartfelt I thanked him for the excellent medical care I received, for the dedication that still brings him to the hospital, in spite of the pandemic, the fatigue, the unvaccinated, the anger...  
in spite of his daily stress tests.

# HOLIDAY RECIPE

\*This is considered a favorite during Kwanzaa.\*

## Chicken Stew with Cornmeal Dumplings

### Ingredients

- 1-14 ounce can chicken broth
- 1 cup frozen small whole onions
- ½ cup water
- ½ teaspoon salt
- 1-10 ounce package frozen mixed vegetables
- 2 teaspoons snipped fresh basil, oregano, or dill; or 1/2 teaspoon dried basil, oregano, or dill, crushed
- ⅛ teaspoon garlic powder
- ⅛ teaspoon black pepper
- 1 cup milk
- ⅓ cup all-purpose flour
- 2 cups cubed cooked chicken or turkey or two 5-ounce cans chunk-style chicken or turkey



\*You can use a pre-cooked store bought rotisserie chicken\*

# HOLIDAY RECIPE

## Chicken Stew with Cornmeal Dumplings

### Directions

#### Step 1

In a large saucepan combine chicken broth, frozen vegetables, onions, water, dried herb (if using), salt, garlic powder, and pepper. Bring to boiling.

#### Step 2

Meanwhile, in a small bowl combine milk and flour; stir into vegetable mixture. Stir in chicken. Cook and stir until thickened and bubbly. Stir in fresh herb, if using.

#### Step 3

Drop dumpling mixture from a tablespoon to make 4 to 8 mounds on top of the bubbling stew. Simmer, covered (do not lift cover), over low heat for 10 to 12 minutes or until a wooden toothpick inserted in a dumpling comes out clean.

#### Step 4

**Makes 4 servings (about 6 cups)**

# HOLIDAY RECIPE: PUMPKIN SOUP

## Seasoning:

- 1 small onion, coarsely chopped
- 1/2 green bell pepper, coarsely chopped
- 1/2 red bell pepper, coarsely chopped
- 1/2 yellow bell pepper, coarsely chopped
- 6 scallions, coarsely chopped
- 6 garlic cloves, coarsely chopped
- 1 cup coarsely chopped parsley leaves with tender stems
- 1/2 cup olive or canola oil
- 6 basil leaves

## Soup:

- 1 cup distilled white vinegar, divided
- 2 pounds stew beef (preferably chuck) cut into 1" cubes
- 16 cups beef or vegetable broth, divided
- 1 medium calabaza or butternut squash (about 2 pounds), peeled, cut into 1" chunks
- 1 16-oz. can pumpkin puree
- 1 lime
- 3 large russet potatoes, diced
- 3 carrots, sliced
- 1/2 small green cabbage, thinly sliced
- 1 medium onion, sliced
- 1 celery stalk, chopped
- 1 leek, white and pale-green parts only, chopped
- 1 1/2 cups rigatoni, penne or other pasta
- 5 garlic cloves, diced
- 1 teaspoon garlic powder
- 1 teaspoon onion powder
- 3 1/2 teaspoons salt
- 1/2 teaspoon freshly ground black pepper
- 1 parsley sprig
- 2 tablespoons olive oil
- 1 tablespoon butter, unsalted



# **HOLIDAY RECIPE: PUMPKIN SOUP**

- 1. Combine all ingredients for the seasoning in a blender or food processor. Blend until smooth like a paste.**
- 2. Pour 1 cup vinegar into a large bowl. Swish stew beef in vinegar to rinse. Transfer beef to a colander and rinse with water.**
- 3. Stir Seasoning Base, juice from lime, and salt in another large bowl. Add beef, toss to coat and marinate at least 30 minutes.**
- 4. Heat 6 cups broth in very large stock pot over medium heat. Add marinated beef, cover, and simmer until meat is beginning to soften, about 40 minutes.**
- 5. Add squash to pot on top of beef, cover, and return to a simmer. Cook until squash is fork-tender, 20–25 minutes.**
- 6. Add can of pumpkin to the broth.**
- 7. Add potatoes, carrots, cabbage, onion, celery, leek, rigatoni, cloves, garlic powder, onion powder, 2 1/2 teaspoons salt, 1/2 teaspoons pepper, parsley, and remaining 10 cups broth. Simmer, uncovered, until pasta and vegetables are tender, 30–35 minutes.**
- 8. Add oil, butter, and remaining 1 tablespoon vinegar. Reduce heat to medium-low and simmer until beef is very tender, for 15–20 minutes more. The soup serves 15.**

## **Did you know that an African-American invented what has evolved into the modern day mailbox?**

In 1891, Philip B. Downing invented what he called the "street letter box". His invention made it easier for people to mail letters without having to travel long distances to the post office. The letter boxes were placed near people's homes along mail carriers' routes.

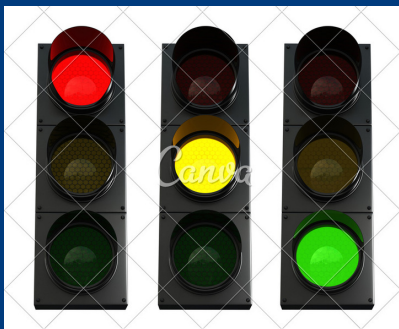

## **Did you know that an African-American invented the gas mask and the traffic light?**

Garrett Morgan created a hooded breathing device which allowed for easier breathing when around smoke, gas and other pollutants. Morgan patented the "safety hood" in 1914. The "safety hood" was used by fire fighters and became the prototype for the gas masks used by soldiers during World War I.

While living in Cleveland, Ohio, Morgan witnessed an accident which prompted him to create the first automatic three-way traffic signal system. In 1923, Morgan created the three way traffic signal that included a warning light to let drivers know when they need to stop.
