

## **ANNEXATION PROTEST VOTE INFORMATION LAFCO PROPOSAL 3216**

When we win Protest 3216, all citizens of Upland and San Antonio Heights will have the opportunity to vote by ballot “for or against” the annexation of fire services and a proposed New Illegal Special Tax of \$152.68 with an increase up to 3% per year thereafter. This is our Constitutional Right as Americans to be given the opportunity to vote for all new taxes imposed on citizens in the United States. **Thank you for helping us attain this goal by submitting your written protest form immediately.**

The LOCAL AGENCY FORMATION COMMISSION (LAFCO) protest form can appear complicated, so to make sure all forms qualify, we are providing the following instructions to complete the Protest Forms exactly as noted to be counted.

- **REGISTERED VOTER** – Any resident who is registered to vote in the City of Upland or San Antonio Heights can fill out this section. The registered voter portion requires you insert your name and address exactly as it appears on the Voter Registration Card. You can confirm this information by going to <https://voterstatus.sos.ca.gov/>
- **LANDOWNER Portion** – Should be completed by landowners of property in San Antonio Heights or Upland. Insert the name of the landowner as it appears on the property tax statement, the address of the actual parcel in San Antonio Heights or Upland and the Assessor’s Parcel Number. If you do not have your parcel #, you can find it by going to <https://www.mytaxcollector.com/trSearchProcess.aspx> If your parcel is in a Trust, it will only require one signature but if the property is listed as joint tenancy or husband and wife, you will both need to complete individual separate forms.
- **AGENT Portion** – This portion is for Agents to protest on behalf of large landowners or corporations. If you feel that you fall into this category, please contact John Goss (909) 705-0672 and he will assist you in filling out this section of the form.

**JULY 11, 2017 - DEADLINE TO COMPLETE FORMS:** The forms *MUST* be completed and turned in as soon as possible! LAFCO will receive protest forms prior to July 11, 2017, but this is the day of the Hearing at Upland City Hall, 6 p.m. – PLEASE TURN THEM IN PRIOR TO THIS DATE.

**There are two “Drop Box Locations” for your convenience. One at CABLE AIRPORT on Benson in Upland located at the entrance of the café and the other at EUCLID VILLAGE CLEANERS (next to Giuseppe’s Restaurant) on Euclid Avenue above 24 Street in San Antonio Heights.**

We would like to have the forms dropped off at one of these locations so we can count and determine how many more signatures are needed. If you need assistance in having one of our volunteers pick up your protest form, please call our MESSAGE # 909 638-1673. We need just under 11,000 Registered Voter Protest Forms or 6,000 Landowner Protest Forms.
