Upon return of the dog, and after receiving written proof from the examining veterinarian of the dog's problems, purchaser shall be offered a full refund of purchase price. It is agreed to and understood that the purchaser is responsible for all veterinary bills incurred while the dog is in his/her/their possession and for all transportation costs back to the seller.

to the seller within 36 hours of the problem being discovered and must not have been

exposed to any contagious diseases.

The seller understands that not having the dog examined by a licensed veterinarian within 72 hours of the dog leaving the seller voids this warranty.

Furthermore, it is the buyer's responsibility to provide the dog with continued vaccines, routine health care and a safe living environment. Should the dog contract a contagious disease, medical condition or injury while living with the buyer, House Woller is released from liability and all treatment for this disease, condition or injury. All treatment for disease, injury or medical condition will be the responsibility of the buyer.

At no time shall the buyer give their lagotto "fish" flavored dog food or any type of dog food with any type of "fish, ocean meal or any form of ethoxyquin" as an ingredient/ preservative written on the food label or not. This includes any prescription foods prescribed by a Veterinarian.

The purchaser understands that feeding their Lagotto any type of raw food or "fish" flavored food, as they will immediately void any and all warranties included in this agreement. It is the buyers responsibly to provide Lagotto of House Woller records to the seller should this part of the health warranty be in question.

The buyer agrees to NOT allow their new lagotto to potty in any highway or airport terminal "potty spots". This includes rest areas or grassy areas along the interstate where dogs will frequently potty.

These areas are potential "hot spots" for illnesses, some potentially fatal illnesses, such as parvovirus and/or distemper, bordetella, and/or the canine flu. They also potentially contain parasites such as giardia, coccidia, fleas and ticks. During transport home, the buyer agrees to use a potty pad for their lagotto to relieve themselves on. (See HOW addendum 2 for more).

The buyer agrees to not permit vaccines for leptospirosis and lyme to be given to their lagotto on the same day. or within 4 weeks of each other. Additionally these two vaccines are not to be given on the day that with any other vaccines are given. These two vaccines can have potential side effects and need to be given only when the risk of the illness outweighs the risk of the vaccine. The buyer agrees to not permit vaccines that are over "6 ways."

Vaccines

Your puppy was vaccinated by our supervising veterinarian using the vaccine protocol outlined by the nomograph provided to us by Dr. Laurie Larson of the University of Wisconsin (see attached).

You need to have follow up vaccines with your local veterinarian. Every State has its own rules and laws regarding vaccines. Additionally, you need to pay attention to the types of canine illness in your area as your puppy could be at risk.

JUST BECAUSE YOUR PUPPY WAS VACCINATED DOESN'T MEAN THAT THEY ARE PROTECTED. Your puppies nomograph was provided so that your vet has a better idea of when the vaccines will be the most effective for your puppy. Minimally, your lagotto should be vaccinated for distemper, parvovirus, corona, parainfluenza and adenovirus. All States within the US require that puppies MUST be vaccinated for RABIES at 16 weeks of age.

We require titer testing for distemper and parvovirus outlined in your puppy vaccine section.

We do not vaccinate your puppy for the canine flu, lepto, or lyme prior to leaving our home. Dependent upon where you live within the United States, you might need to vaccinate for these conditions. Please consult your vet about this decision. It is your responsibility to ensure that all vaccines are provided to your puppy on time.

Do not give your puppy the lepto or lyme shot together or with any other vaccines due to the possibility of serious side effects.

If you live within a canine "hotspot" for certain canine illnesses, it is your responsibility to know and understand the "hotspot" condition in your area, take precautions to protect

your puppy and have your puppy vaccinated for the "hotspot" condition as soon as possible.

Failing to vaccinate your puppy, voids your health warranty. Bordetella vaccines are given to dogs every six months if they are socialized around other dogs or in performance homes (i.e. dog shows, dog classes, etc. Do not allow your puppy to engage in any socialization activities until they are minimally 16 weeks old (with your vet's clearance).
