AN ORDINANCE OF THE VILLAGE OF INNSBROOK, MISSOURI, TO AUTHORIZE THE TRANSFER OF THREE EASEMENTS ALONG HIGHWAY F FROM THE VILLAGE OF INNSBROOK TO THE MISSOURI DEPARTMENT OF TRANSPORTATION.

WHEREAS, the Village of Innsbrook acquired permanent drainage and slope easements on three parcels of land as authorized by Ordinance Nos. 180, 181 and 185 for the Highway F Shoulder Project; and

WHEREAS, upon completion of the Highway F Shoulder Project the Missouri Department of Transportation (MODOT) has released the permit and accepted the project; and

WHEREAS, the Village of Innsbrook authorizes the transfer of said easements by deed to the Missouri Department of Transportation so that MODOT can provide maintenance to said areas.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF INNSBROOK, MISSOURI, AS FOLLOWS:

Section 1. The Board of Trustees of the Village of Innsbrook authorizes the transfer of three permanent drainage and slope easements, as authorized by Ordinance No. 180 (Max Gale property), Ordinance No. 181 (Hollenbeck property) and Ordinance No. 185 (Nathaniel Kammeier property), to the Missouri Department of Transportation. as described in Exhibit "A" attached hereto and made a part hereof.

<u>Section 2.</u> Said easement deed shall be recorded by the Missouri Department of Transportation in the Office of the Recorder of Deeds of Warren County, Missouri.

Section 3: This Ordinance shall be in full force and effect from and after its passage by the Board of Trustees.

Said Bill was passed and approved this 14th day of April, 2015 by the Board of Trustees of the Village of Innsbrook after having been read by title two times prior to passage.
