

- Ordinance No 630-

an ordinance appropriating certain Money's

Be it ordained by the mayor and Board of Commissioners of the city of Garnett.

Section One:- that the sum of Six Hundred and No/100 -----
----- Dollars be and the same is hereby appropriated
out of the main Sewer Interest Bond Fund in the hands of the city
Treasurer to pay the bills allowed against said Fund at a regular meeting
of said Board held on the 17th day of May 1915, which Bill is for the ~~purpose~~
purpose of paying the interest on the Bonds due June first 1915. a list
of which may be found on page 214 of the journal of the proceedings
of the Board on said date.

Section Two:- that the sum of One Hundred and Thirty Four and 40/100
Dollars be and the same is hereby appropriated out of the Funds of
Sewer District No 2 in the hands of the city treasurer to pay the
bills allowed against said fund at a regular meeting of said Board
held on the 17th day of May 1915. a list of which may be found on page 214
of the journal of the proceedings of the Board on said date.

Section Three:- that the sum of Ten and 50/100 Dollars be and the same is
hereby appropriated out the funds of sewer District Number (3) in the
hands of the city treasurer to pay the bills allowed against said Fund
at a regular meeting of said Board held on the 17th day of May 1915.
a list of which may be found on page 214 of the journal of the
proceedings of the Board on said date.

Section Four:- that the sum of Fifty One and 30/100 Dollars be and the
same is hereby appropriated out of the Electric Light Fund in the
hands of the city Treasurer to pay the Bills allowed against said Fund ^{charges}
held on the 17th day of May 1915. a list of which may be found on page
^{meeting} 214 of the journal of the proceedings of the Board on said date.

Section Five_ that the sum of Seventy and no/100
----- Dollars be and the same is hereby appropriated
out of the General Fund in the hands of the city Treasurer to pay the
bills allowed against said fund at a regular meeting of said Board held
on the 17th day of May 1915. a list of which may be found on page 214 of
the journal of the proceedings of the Board on said date.

Section Six:- that the sum of Thirty Six and 66/100
----- Dollars be and the same is hereby appropriated
out of the Water Works Fund to pay the bills allowed against said Fund
at a regular meeting of said Board held on the 17th day of May 1915.
a list of which may be found on page 214 of the journal of the proceedings
of the Board on said date.

Section *Seven* that the Mayor and city clerk are hereby authorized and instructed to draw warrants on the city treasurer to pay the bills allowed in sections one- Two- Three- and Four *Five and six* of this ordinance.

Section *Eight* that ~~the ordinance~~ this ordinance shall take effect and be in force from and after its passage by the Board of Commissioners and its approval by the Mayor.
