## **Parking-Enforcement**

We have had an increase in street parking and garage use violations. After years of seeking voluntary compliance with our existing rules, the BOD has approved the addition of a patrol service for our community. This service has been enlisted to take on the enforcement process for our parking rules. Please make yourself familiar with our rules. All of our governing documents and guidelines are available for review or download on our website. In a "Nut Shell", all owners are expected to park 2 vehicles in the garage. Third vehicle and oversized vehicles may be granted an exemption after inspection by the patrol service and BOD review. Safe listing of overnight visitor parking will be available and the process will be laid out in the documentation from the patrol service. More information regarding this will be sent to each member prior to "Go Live" and enforcement.

Owners that rent their properties are responsible for communicating rules to their tenants. Failures to follow rules and subsequent fines are the responsibility of the owner. Please make sure your tenants receive communication regarding rules and processes regarding the patrol service.
