"Many factors determine the shape of a nose; most important is what a patient wants his or her nose to look like. Some patients are young, so I consult with both patient and the parent before giving my opinion based on shape and size of a patient's face and features. A nose must fit a person's body and ethnicity for a natural result, so I keep the nose close to its normal shape, but reconstructed to a more beautiful and natural look. For some nose surgeries less is enough. The above case was a nose revision I did on bad nose surgery that left this patient with a 'crooked boxers' nose."





"Neck restoration patients who get the most improvement have thin necks, good skin elasticity. and great genetic makeup that allows them to heal quickly. I use surgery/laser regeneration prior to the surgery, or six months after the surgery. This combination achieves excellent results."

"Under eye bags are fat pushing outward, retention of fluid; or both. Puffiness from fat is easily removed, critical is removing the correct amount. Removal of fat from the lower eve area must always be conservative to avoid 'hollow eye' as patients age. When removing eye area fat, I suggest to patients to relocate body





fat to sunken temple areas. If prior bad surgery removed too much fat, I recommend fat transfer to the interior rim of the eye to very slightly fill depressed areas. For those with complications out of my area of expertise, I refer to a qualified colleague I trust who specializes in complex eyelid cases. Using filler to correct a sunken look may be popular (less work for a doctor and low cost) but over-filling this area makes eyes look worse, more puffy, and resembles a hangover, or someone with a tendency to retained too much water under the eyes."

## SculpSure vs Micro Liposuction micro contouring without a suction device



SculpSure laser was introduced to my practice as the only FDA approved laser to permanently melt fat. The 25-minute treatment is done without local anesthesia, needles, or sutures. Patients drive themselves to/from the office and can exercise the same day."





"SculpSure adds a dimension to an art I practice that most plastic surgeons can't do as they perform liposuction with general anesthesia/intravenous sedation, and a suction device. I remove fat in tiny increments for meticulous body contouring with no suction machine known as Micro Liposuction. It takes longer, but results are superior to machine assisted liposuction. SculpSure requires no anesthesia or post operative compression garment, however it can take 2-3 treatments to achieve the same results as conventional liposuction."
