Karen Margulis to give April 19 'Expressive Pastels' virtual demo

Our demo will start following a brief 7:00 pm business meeting, and will end by 9:00 pm.

Jeff interviewed Karen a couple of weeks ago and sums up his impression thus: "What does a butterfly have to do with composition? How do you make your palm trees glow? How do you start a painting? In this interview Karen Margulis discusses the answer to these questions and more. Over the years we have seen many pastel demo's, but an articulate Karen Margulis will also lecture. She explains in Jeff's interview how to use this versatile medium expressively with a little planning and thoughtful selection of a

color pallet. Yet the key seems to be building an underpainting *before* taking a serious look at your reference photo. Jeff's interview includes a very interesting three minutes (timeline minutes 20-23) on how one makes an underpainting using soft pastels.

Karen talked to Jeff about painting daily, even if she can only squeeze in 10-15 minutes, and about painting with passion. When the passion wanes she simply stops and makes a list of limited things to finish when time and passion return. Karen also talks about composition and the importance of engaging the viewer.

On her web site, in a paragraph titled "About Me," she says "I was born in Connecticut, grew up in South Florida and spent summers in the North Carolina Mountains. I currently live in Marietta Georgia, just outside of Atlanta. I graduated from the University of Florida with a BA in Education. I operated a family day care for 21 years so that I





could stay home with my own 2 children. We traveled every summer with the kids and tried to visit every National Park. Most of my paintings are inspired by the photos I took on these adventures. I am now painting and teaching pastel classes and workshops full time." She is represented by several galleries in the Southeast as well as several online galleries, and she is a Member of Excellence in the Southeastern Pastel Society and a Signature Member of the Pastel Society of America. Karen just (October 2020) did an Expressive Pastels workshop for Main Street Art Center in Lake Zurich.

We select CLC Studio Art and Digital Media & Design scholarship winners in April

The 2021 LCAL and Phoebe Boyd Scholarships will be awarded to CLC students for the 40th Annual CLC Student Art Competition April 9 – May 14, 2021.

The show is open to Studio Art and Digital Media & Design students attending CLC from Spring 2020 through Spring 2021. This is a juried show and students can submit up to two pieces of work that were part of a class assignment. Accepted work will be shown on the Robert T. Wright Community Gallery of Art website (http://www.clcillinois.edu/campus-life/arts/wright-gallery) from April 9-May 14, 2021.

This year, in addition to the virtual show, there is a possibility that some pieces may be displayed as "**popup** shows" at the Gurnee Mills Mall. *Should this happen we will let you know*.

Selecting the LCAL and Phoebe Boyd Scholarships for this show will be LCAL members Mary Haas, Clarese Ornstein, and Mary Neely.

April 10 is the last day for Spring Membership Show submittals

Our critique artist Sandie Bacon will present each piece on your computer screen, much like a Power Point presentation, but she will be able to enlarge details to discuss technique.

Submittals for the Spring Membership Show are being accepted through Saturday April 10. Submittals, all emailed to <u>chrisetanner@sbcglobal.net</u>, will be put into a standardized high-resolution format for a show catalog to be used by our critique artist and our members.

The concluding virtual critique is May 17, 7-9:00 pm, in a Zoom meeting.

Our members will receive a link to the show catalog around April 15 and will be reminded to not share that outside the membership because of important artist copyright concerns. Zoom allows us to record the critique, and that recording will be available to members on our web site for one year. The critique video will have a limited image resolution that overcomes copyright concerns, so that's something we *can* share outside the membership.

LCAL show in Antioch Fine Arts Foundation gallery is suddenly on hold

We recently confirmed that many of our members would like to have a "live" show in the AFAF upstairs gallery as early as July, enough to make that seem feasible. However, AFAF just learned that their building ownership has changed hands. The new owner must now approve of the use of building spaces and the rent AFAF must pay.

April 3 started 2021 plein air season

The 2021 Lake County Art League plein air effort is dedicated to the memory of Skip Wiese.



It was too soon for the color, shapes and shadows of trees in our landscapes, so we opted instead for storefronts of downtown Grayslake. Lake County village centers offer great plein air opportunities, so expect to see more of them while we paint our way to summer. Besides commercial and cultural visuals, there are surprising details to play with, like the utilitarian backs of these same stores, or overhead wires in the alleys.

For the first time since we began painting *en plein air* in 2006, we started at noon to capture unseasonably warm temperature that ranged from 60 to almost 70 degrees while we were there. There is plenty of space in downtown Grayslake for artists to scatter and explore, so we felt free to share our notice with other art groups familiar with managing the risks of gathering during the pandemic.
