

# 2025 NJOMA Election Information and Application Candidacy Deadline: November 8, 2025, at 5:30 p.m.

According to the NJOMA Bylaws, Article V – Board of Directors, Section 1 Composition: The NJOMA Board of Directors shall consist of representatives from each of the eight (8) Regions, three (3) At-Large Regions, and one (1) National At-Large. Any member of the Association that desires to change the number of members of the Board of Directors to ensure the efficient operation of the Association must adhere to Article XII criteria.

Elections will take place at the 2025 NJOMA Conference for the following:

### Four (4) Regions

#### Region 2 ~ Region 5 ~ Region 7 ~ Southwest At Large

#### Filing for Candidacy:

- 1. All candidates must be a general member in good standing and attend the 2025 Conference.
- 2. All candidates must have a <u>paid registration or a purchase order from their sponsoring</u> <u>organization documented with their name</u> by filing deadline of November 8, 2025.
- 3. Candidates must submit a written Declaration of Candidacy (form attached) and pay a \$20 fee by filing deadline of November 8, 2025, at 5:30 p.m.
- 4. Candidates must be willing to commit and comply with items outlined in the Board Member Job Description (form attached).
- 5. Candidates must adhere to the procedures outlined in this form.
- 6. Candidates must attend scheduled Caucus meetings.
- 7. Candidates must attend the Board Candidate Orientation Workshop on November 8, 2025.
- 8. If elected to the NJOMA Board of Directors, new members must attend the mandatory NJOMA Board of Directors' meeting on Wednesday, November 10, 2025, at 3:00 p.m.

### **Election Protest:**

The Election Committee will consider any election protest filed by a declared candidate submitted by 5:30 p.m. on the final day of the conference. Following the protest filing deadline, the Election Committee will meet and render a decision by 6:00 p.m. The decision of the Election Committee will be final.
