7. How has the Affiliate embraced and promoted acceptance and inclusion of all cultures in their parish/congregation?
8. In what ways is the Affiliate involved in Community Service?
9. How would the Affiliate say that belonging to the Diocesan Council of Catholic Women has enriched their membership?
10. What has the Affiliate done to increase their membership/reach out to all women?
11. How has the Affiliate supported the mission and programs of DCCW?
12. Any other comments and information you would like to include (numbers served by activities, etc.)
