

TOWN COUNCIL MEETING

September 21, 2020

The Town Council met September 21, 2020 at 6:00 p.m. in the Thorsby Municipal Annex Building.

Mayor Hight called the meeting to order at 6:00p.m. Mayor Hight gave the invocation.

Mayor Hight asked for approval of the Council Minutes from September 8, 2020.

Council Member Littleton moved to approve the Council Minutes from September 8, 2020 as presented. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Chapmen, Littleton, Benson, and Crumpton.

New Business

Mayor Hight recognized Calvin Cassady from The Cassady Co.

Calvin explained the change order for the Rebuild Alabama Grant for \$88,591.32 and the total project would be \$279,347.73.

Council Member Benson moved to approve Resolution #9/21/2020 (Change Order No.1 to close out Rebuild Alabama Grant Project No. 11-2020-480). Council Member Chapman seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Chapman, Littleton, Benson, and Crumpton.

Calvin explained Resolution #2020-9-21(Excise tax on gasoline and diesel fuel).

Council Member Littleton moved to approve Resolution #2020-9-21 (Excise tax on gasoline and diesel fuel). Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Chapman, Littleton, Benson, and Crumpton.

Calvin Cassady gave all ticket for the paving project to Town Clerk Crystal Smith to put with the grant paper work.

Department Heads

Chief Barnett was not present.

Fire Chief Parker reported to the Council about the fire last week, he stated that Jemison will always respond to all fire calls because they are on duty 24hrs. Chief Parker stated they both arrived at the same time and Thorsby had 9 firemen to respond. He said the fire is under investigation with the fire Marshalls office. The Council thanked Chief Parker.

Mayor Hight stated there are a few changes for the 2020/2021 budget for the Police Dept. and Fire Dept. Mayor Hight explained that Chief Barnett wanted his budget to stay the same, that he did not want to take from Butterfly Bridges to leave it at \$2000.00.

Council Member Benson moved to change the Police Dept. budget line for Butterfly Bridges back to \$1500.00. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Chapman, Littleton, Benson, and Crumpton.

Mayor Hight then reported that Boise Cascade is going to purchase the Cardiac Monitor for the Fire Dept. Chief Parker stated he has spoke to them and they are going to purchase the monitor and then donate it to the Fire Dept. That being said Mayor Hight asked the Council to change the Fire Dept. budget, to move the money for the Cardiac Monitor to Salaries and let Chief Parker work on a night shift plan, and report to see when they have the most calls.

Council Member Chapman moved to change the Fire Dept. budget line for Cardiac Monitor to Salaries. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Chapman, Littleton, Benson, and Crumpton.

Council Member Littleton moved to approve the Budget for 2020/2021. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Chapman, Littleton, Benson, and Crumpton.

Mayor Hight stated that Council Member Collins had been taken to the ER with chest pains, Tiffany her daughter asked everyone to pray for her.

Mayor Hight reported to the Council that the Swedish Fest committee is asking for the Council to work the Swedish Fest booth this year.

Mayor Hight reported that all new flags have been ordered for Richard Wood park and also a new flag pole for the park as well. He also stated that all swings has been ordered and should be here this week.

Council Member Crumpton moved to approve the Financial Statement for August as presented. Council Member Chapman seconded the motion the motion carried with the votes being as follow: Yeas: Council Member Chapman, Littleton, Benson, and Crumpton.

Council Member Littleton moved to approve the transfer of funds, and bills for September 21, 2020. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Chapman, Littleton, Crumpton and Benson.
