Birthday Party Agreement

This contract represents an arrangement between Edgez Dance LLC, and "Individual" as named below. The following agreements apply to every instance in the future in which the individual intends and is allowed to use the facility of Edgez Dance. If this individual fails to uphold any of the following agreements, individuals facility privileges may be revoked.

1. Reservation of dates: individuals must reserve the date of interest 2 weeks before. The date and time of interest must not conflict with Edgez Dance LLC's schedule. Edgez Dance LLC reserves the right to refuse reservations at its sole discretion.
2. Payment: Individual will provide full payment for all reservations of studio space in US funds. The date of the party will not be held until this payment is received and cleared. Payment is not refunded unless notice of cancellation is made at least 48 hours before the individual's reservation date (individual will receive a ½ refund if cancellation occurs prior to 48 hours before the reserved date). If Edgez Dance must cancel an individual's reservation, the individual will receive a full refund. The individual will pay at least 1 week before the time of each reserved period, and are encouraged to pay in advance as much as possible.
3. Deposit: There is a deposit of \$150 due to hold your reservation. A \$100 deposit that will go towards your party package and a \$50 refundable damage deposit that is required. The deposit of \$50 will be refunded after the date of the event to ensure clean-up is completed and no damages are assessed. All checks must be written to Edgez Dance.
4. Length of Use: Individuals using Edgez Dance will be allowed to enter 30 minutes prior and will be given 30 minutes after their allotted time for clean-up. Studio clean up must be completed by the end of the rental period. If the studio is not satisfactorily returned to the state it was prior to the rental period, a clean-up fee of \$25 will be owed. Overtime will be calculated in increments of 15 minutes beyond the contracted end-time of the rental period when an individual is either still using or cleaning up the studio space. Overtime fees will be \$10 per 15 minutes over. Do not arrive late - individual's rental time begins promptly at the designated starting time and ends promptly at the designated ending time, there will be NO exceptions.
5. Terms of Use: Use of our studio and our equipment is AT THE INDIVIDUALS OWN RISK. The individual hereby waives rights to seek legal redress for mishaps, accidents, and/or loss while on our premises. The individual agrees to leave the studio and adjacent grounds in the

same condition as they were when the individual arrived. Individuals are solely responsible for any legal infractions individual or members of an individual's party made during the conduct of the use, be they in our studio or elsewhere. This includes parking tickets, all other violations or citations, and legal action resulting from the use of the space. The individual agrees to hold harmless Edgez Dance LLC, its owner, representatives, landlord and contractors acting on its behalf for any loss, accident, or injury to the individual 's self or anyone who accompanies the individual while on our premises. individuals agree to be solely responsible for the conduct and welfare of all persons accompanying an individual while on our premises. individuals are solely responsible for the safety and well-being of any person individual engages. individuals understand that if Edgez Dance LLC observes dangerous, negligent practices or activities are being engaged in the Company reserves the right to stop the use and require the individual and individual 's party to leave immediately. individuals agree to hold Edgez Dance LLC, representatives, and anyone acting on behalf of Edgez Dance LLC completely harmless from any action, legal or otherwise, that results from the individual 's conduct. individuals agree that someone from Edgez Dance LLC, as a representative, will be present in the studio at all times individuals are using it.

6. The individual will assume full responsibility for any damage caused to any part of the entryway, studio, back rooms, bathroom, stereo equipment, floors, windows, mirrors, walls, ceilings, etc. sustained during the individual 's scheduled studio time. Each individual agrees to pay in full for repair or replacement of any item or structure damaged by the individual s or by performers, collaborators, or guests invited to Edgez Dance LLC by the individual . Any damages to equipment such as stereo, mats, barres, or other personal property owned by Edgez Dance LLC will also be replaced at individual 's expense. Full payment for damage will be made within ONE MONTH of the damage. Edgez Dance LLC is not liable for acts out of its control such as power outages, weather or emergencies. In such cases, Edgez Dance LLC will refund half of the individual 's payment.

8. Storage: The individual may NEVER leave any equipment, costumes, props or personal belongings anywhere in the studio, hallway, bathroom, or back rooms.

9. Miscellaneous: This Agreement incorporates the entire understanding and agreement between the individual (_____) and Edgez Dance LLC. Any modifications of this Agreement must be in writing and signed by both parties. The parties have read both this entire Agreement, agree to all its terms, and acknowledge receipt of a complete copy of the Agreement signed by both parties. Each person signing as the individual below shall be fully responsible for ensuring that full payment is made pursuant to the terms of this Agreement.
