**RESOLUTION NO: SL-74-2024** 

- TITLE: FINAL ECONOMIC RELIEF ASSISTANCE PAYMENT OF ARPA FUNDS
- WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers of the Summit Lake Paiute Council (see Article II, Section 1); and
- WHEREAS, the Summit Lake Paiute Council has the power and duty to represent the Summit Lake Paiute Tribe in negotiations with Federal Governments in matters to benefit the general welfare of its tribal membership; and
- WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the boundaries of the Summit Lake Paiute reservation; and
- WHEREAS, the Council received input from tribal membership regarding their needs for food and general assistance due to the continuing negative impact from quarantine and illness from the ongoing coronavirus pandemic; and
- WHEREAS, the Council considered the needs of the tribal members and reviewed the U.S. Department of the Treasury's publication "Coronavirus State & Local Fiscal Recovery Funds: Overview of the Final Rule" received in January 2022 with final rule effective April 1, 2022; and
- WHEREAS, the Council declared to issue three economic stimulus payments distributed from the 2021 American Rescue Plan Act funding to all eligible adult members in the amount of \$2,000.00. Two payments of \$2,000.00 have been issued: June 1, 2022, and December 1, 2022; and \$4,000.00 issued on June 1, 2023.
- WHEREAS, the Tribal Membership has continued to express the financial hardships continuing from the COVID-19 Pandemic; and
- WHEREAS, the Tribal Council took into consideration the request and need from the membership and has agreed to initiate one final economic stimulus payment in the amount of \$1,650.00 to be released December of 2024 in the last effort to financial aid our membership in the continued financial fight of the Pandemic that has crippled our membership since 2020; and
- WHEREAS, the eligible members to receive the final economic payment December 2024 must be adult tribal members age 18 years of age or older as of November 30, 2024; and

**NOW THEREFORE BE IT RESOLVED** that the Summit Lake Paiute Council hereby declares to approve one final Economic Relief Disbursement from \$1,650.00 to be disbursed December 2024, to all adult tribal members aged 18 years of age and up effective November 30, 2024.
