## **REGULAR MEETING – Call to Order**

Chair Tonn thanked everyone for joining an hour later than usual to accommodate the Great Washington Shake Out Earthquake drill.

## **BPC Staff Report.**

- ➤ BPC Executive Director Jaimie Bever virtually attended the first annual Cal Maritime Pride in Maritime Summit, which was a hybrid event held earlier this week. The BPC looks forward to future summits and hopes to help publicize and possibly sponsor future events.
- ➤ Jaimie reported that the WA State Office of Equity will be holding their annual Equity Summit We the People on October 25 and 26.
- The Women Offshore Conference was one of the cover stories in our recent edition of the BPC Pilotage Quarterly. Both PSP and the BPC have sponsored the conference and both Executive Director Jaimie Bever, Training Program Manager Jolene Hamel, as well as Puget Sound Pilot Trevor Bozina will be heading to Texas A&M Galveston for the conference next week.
- In preparation for the Key Performance Indicators Workshop #3 in November, BPC Program Analysist Bettina Maki recapped the work done to date at Workshop #1 in March and Workshop #2 in April. The commissioners will be provided with the KPI Matrix document with the latest revisions from Workshop #2 and other information to help inform the November discussion. It was restated that while the authorized number of pilots is an element of the Pilot Training and Licensing KPI, the Workshop is not the mechanism to increase or decrease the number of pilots. If, or when, a hearing to set the number of pilots is opened, then the revised number will be incorporated into the KPI. Chair Tonn stated that she will be allowing the public to comment on the draft KPI documents prior to Board adoption. The KPIs will not be adopted at the November Board meeting, but at a later meeting. The workshop will take place from 1000-1200 with the Board meeting starting at 1200 and may run a bit longer than usual.

## **BPC Chair Report.**

- ➤ BPC Chair Sheri Tonn reported that she is preparing for travel and that she will be attending the Women Offshore Conference virtually.
- > Chair Tonn and Executive Director Bever met with UTC Chair David Danner for a pilotage tariff rate case briefing earlier this month.

<u>The Northwest Seaport Alliance (NWSA)</u> offered current and projected statistical data as well as updates on current maritime issues and activities.

BPC Data Analyst Bettina Maki shared the Puget Sound Pilots Activity Report dashboard and was available for questions.

## **Trainee Evaluation Committee (TEC)**

- Consideration of Licensure of PSPD Pilot Candidate: Captain Stephen Scott. On behalf of the Trainee Evaluation Committee (TEC), TEC Vice Chair Anthony stated that Captain Steve Scott has completed all sections of his Training Program Agreement including successful Portable Piloting Unit (PPU) training and completion of his federal licensing requirements. The Board has received his TPTR Summary and all training comments. Captain Scott started training in February 2022 and completed 319 trips.
  - <u>Motion</u>: Farrell/Drennen issue Captain Stephen Scott state pilot license number 224 for the Puget Sound Pilotage District Carried.
- ➢ Pilot License Upgrade Program: Captains Mann & Riddle. TEC Vice Chair Captain Anthony reported that the TEC reviewed the 2 upgrade letters for Captains Mann and Riddle. Motion: Anthony/Hamilton – approve the pilot license upgrade program for Captains Mann & Riddle as recommended by the TEC – Carried.
- > The TEC met yesterday and reviewed all trainee progress. With today's licensure, there are now 8 trainees in PS and zero trainees in GH. Two trainees came to the TEC yesterday to transition to Evaluation, which now makes 4 trainees in Evaluation, 1 in Training and 3 trainees in Observation. All are progressing well.
- > TEC Vice Chair Anthony also reported that challenges continue at the REC and there has still been no follow up since the August meeting of the federal pilotage work group. The TEC and BPC will continue to reach out.

## **Vessel Exemption Committee (VEC)**

- ➤ VEC Chair Mike Anthony presented the CR 102 for proposed recommended fee changes in 2024.

- Chair Anthony stated that there were no further committee updates.

## Committee Updates.

## **Pilot Exam Committee (PEC)**

- Training Program Manager Jolene Hamel highlighted the details of the outreach efforts since the application packet was released on October 16 for the Spring 2024 Marine Pilot Exam.
- ➤ Jolene also reported some of the anticipated aspirant responses, including doubling the study group since the 2018 exam, and shared information on the upcoming webinars that will be taking place in November: one webinar hosted by the BPC specific to exam processes and preparation, and the other hosted by PSP regarding pilot life.

## **Pilot Safety Committee (PSC)**

- Commissioner Drennen reported on the PSC meeting that was held on October 12. During that meeting they approved the minutes from the previous meeting and those minutes were provided to the Board.
- Commissioner Drennen also shared the quarterly pilot ladder data and opened the floor for questions on the data.

## **Diversity, Equity & Inclusion Committee (DEIC)**

> Executive Director Bever reiterated the information on the Women Offshore Conference and stated it was not too late to register for the virtual sessions.

## **Oil Transportation Safety Committee (OTSC)**

> OTSC Chair Jaimie Bever reported there will be a public workshop on October 31.

**Public Comment.** Chair Tonn asked for public comment, but no public comment was offered. Training Program Manager Jolene Hamel shared an email question from Mike Moore, PMSA asking for further clarification regarding the potential number of applicants for the upcoming 2024 Exam as well as the number of pilots that this licensure made.

**Confirmation of Next Regular Meeting Dates.** Chair Tonn reminded everyone of the upcoming meetings in November and December. All meetings continue to be hybrid, and all are invited and encouraged to come in person. She also reported that KPI Workshop #3 will be held at the November 16th meeting, from 10:00-12:00 with the Board Meeting starting at 12:00.
