HR 6666 TRACE ACT DUE TO COVID

But that is exactly what did occur in the end for a Senior Living Apartment complex in Ventura, California in particular.

Many have argued and presented evidence that this is precisely the case pertaining to the 'Virus Wars'. The plan has been to release viruses. It has been an on-gong 'Virus War' since the 1980s. What would such a measure look like when it will be passed and be the law of the land eventually? It will essentially be what the UN's Agenda 2020-2030 has called for. It is for an army of Contact Tracers to go house-to-house searching for family members infected with COVID-19. Then there will be the removal of those infected into a 'Mandatory Quarantine Center'.

Targeting the Defenseless

In Ventura, California, apartment complexes were sealed off and those suspected of being infected with COVID were isolated by police. This is the crux of the issue. The Congressman then had to release a statement saying the Bill would not forcibly remove people from their homes. That the main effort was and is to 'provide portable testing units whereby those not able to be tested to have a place to go to'. However, this was not the case as the intent to the outcome became what was feared. For some reason Ventura, California was chosen as a testing ground. Either it was a 'Beta Test' because it is full of Liberals that would capitulate to any government 'mandate' without question. Or it is full of watchful Conservatives and they wanted to see what type of backlash, objections or resistance would occur due to the to the Contact Tracing mandates.

To the contrary, this is what occurred in Ventura in the following. Ventura County officials were forced publicly to apologize and clarify that those who could not isolate or quarantine themselves would never be forcibly removed from their homes as part of an effort to further contain the spread of the Corona Virus. What happened is that the very city officials were caught on video that was circulated on social media of precisely that. It showed Dr. Robert Levin, the Director of the Ventura County Public Health, speaking before the Board of Supervisors. The discussion was about a plan to hire up to 50 new 'Contact Tracing Investigators' to 'find people who have COVID-19. Such were 'to be immediately isolated'. Then to 'find every one of their contacts, to make sure they stay quarantined and check-in with them every day.'

Levin admitted his poor messaging during another press conference, stressing those who test positive or who are identified by officials as having come in contact with an infected person would not be forcibly removed from their homes. But this is exactly what occurred. A quarantine triggered by a handful of COVID-19 cases was lifted days later at a 7-story public housing complex for older and disabled people in downtown Ventura. The quarantine was lifted only after testing nearly all of the 80 residents at The Palms subsidized housing complex. It was a clear over-reach and reaction by the 'caring city officials' over what is essentially a severe 'Flu' really. The tests suggested that the virus had not spread aggressively. Only 1 new positive test emerged since then. This is why it is pathetic and a waste of resources.

Then there was another COVID scare that also emerged in Ventura after a resident of the independent-living complex that is part of the Vista Del Mar Commons housing development tested positive while being hospitalized for an unrelated procedure. Most American presently think that such scenarios that ended-up being true could never happen in the USA. But this Full Spectrum Dominance is already being implemented around the world and in places like Australia, New Zealand and Canada. In Australia, Police are literally wresting-down grandmothers for not wearing a mask. The eventual outcome is that those deemed 'infected' or those not giving consent to testing and or vaccination will forcefully be removed and sent to FEMA Camps in the USA or Detention Centers in other Nations. It is just a matter of reaching the 'right time', or 'crisis', especially for the USA. And what is worse, children will be separated from parents.

This type of separation of families is presently occurring as it pertains to illegal immigrant children that came either accompanied with parents or alone to the USA. Such have been and are still in U.S. Border Patrol Detention Centers. As to this House Bill HR 6666, there was to a degree some concern and write-ups that circulated on the internet mainly but not from the mainstream media. Nonetheless, if the HR 6666 is passed, it will lead eventually, when amended to violate the 4th Amendment that protects Citizens against their government blatant and unconstitutional over-reach. The 4th Amendment guarantees every American Citizen the right to be secure in their own home and person or body. At first, this Bill innocently grants \$100 billion to the CDC Center for Disease Control, a for-profit agency that is invested in the business of vaccines.

The Bill would establish a 'local mobile health unit' in each community of the whole Nation to conduct a diagnostic door-to-door COVID-19 testing program. However, the Act does clearly state that such testing will take place 'at individuals' residences.' The Bill does clearly state that it is aimed, 'to establish the effort to trace and monitor the contacts of infected individuals and to support the quarantine of such individuals.' Thus, the authors are denying what is clearly written in their own Bill. The issue by those that object to the lockdowns is that only sick people should be quarantined and mandated to wear masks, not healthy bodies. What will happen to all those people that will refuse to submit to a test or who are not sick? It is a clear case of being now found 'sick until proven well'. What this bill will ensure is that the authorities will be given blanked powers to detain and remove citizens from their place of being safe in their own person, body and homes. The Bill does not outright specify that Citizens will be forcibly removed from their homes but those deemed 'sick' need to be 'quarantined'. This leads to what is not being said but inferred, a separate facility, whatever type wherein such people will have to be quarantined there. And if need be, against one's will or consent. This TRACE Bill 6666 will set the legal and lawful precedence. It will allow for a massive dragnet type effort to seek and find those 'infected' with a 'severe cold' in what may amount to enforced home invasions. The expectation will be forced compliance by requiring the names of all individuals an infected person has had contact with. This is already the practice at restaurants and some Churches. WASHINGTON — Today, U.S. Representative Bobby L. Rush introduced H.R. 6666, the COVID-19 Testing, Reaching and Contacting Everyone (TRACE) Act. This bipartisan bill would establish a grant program run by the Centers for Disease Control and Prevention (CDC) to fully mobilize coronavirus testing and contact tracing efforts.

Grantees would include Community Health Centers, School Based Health Centers, academic medical centers, non-profits, and other entities who would hire and train individuals to operate mobile testing units, as well as outreach in hot spots and medically underserved areas.

“Reopening our economy and getting back to normal will be all but impossible if we do not step up our testing efforts and implement robust and widespread contact tracing,” said Rep. Rush.

“Until we have a vaccine to defeat this dreaded disease, contact tracing in order to understand the full breadth and depth of the spread of this virus is the only way we will be able to get out from under this.

“The COVID-19 TRACE Act will allow us to do this by creating a \$100 billion dollar grant program for local organizations to hire, train, and pay individuals and to purchase supplies to run mobile testing units and door-to-door outreach as is safe and necessary, with special preference being given to those operating in hot spots and medically underserved communities, as well as those entities who commit to hiring from these neighborhoods.

“I am immensely proud to see this bill receive bipartisan support and I hope to see the COVID-19 TRACE Act swiftly adopted by the House as a stand-alone bill or as part of a larger coronavirus response package.”

Rep. Rush answers frequently asked questions about the COVID-19 TRACE Act:

What is the COVID-19 TRACE ACT?

- The COVID-19 Testing, Reaching and Contacting Everyone Act is a comprehensive, bipartisan bill that would establish a 100 BILLION dollar grant program for local organizations to hire, train, and pay individuals to run mobile testing units and conduct door-to-door outreach, with special preference being given to those operating in hot spots and medically underserved communities.*

- The bill has been officially endorsed by the American Diabetes Association and EverThrive Illinois.*

What is Contact Tracing?

- Contact tracing is not a new concept and is used all over the world to combat infectious diseases such Ebola and tuberculosis. Because coronavirus is highly contagious, contact tracing helps us understand who has the virus, and who they might have come into contact with, so we can better protect those potential patients as well.*

- According to the CDC, contact tracing is a core disease control measure and a key*

strategy for preventing further spread of COVID-19.

- *Given that many people with coronavirus are asymptomatic, contact tracing becomes even more important if we are serious about getting back to work and back to normal.*
- *Moreover, we are currently witnessing more frequent testing in white, affluent communities but more COVID-19 cases and deaths in low-income, minority communities. In Illinois, even though black residents are dying of COVID-19 at more than three times the rate of the state's white population, white residents are still tested nearly twice as often. That is why we need to ramp up testing and contact tracing in these communities and other medically underserves communities as well.*

Who would qualify for grants?

- *Federally Qualified Health Centers;*
- *School-based Health Clinics;*
- *Disproportionate-Share Hospitals;*
- *academic medical centers;*
- *non-profits, including faith-based organizations;*
- *high schools and universities; and*
- *Any other entity deemed eligible by the CDC.*

Does the COVID-19 TRACE Act require testing?

- *No. The COVID-19 TRACE is about providing testing to those who want/need it. Not everyone has the ability to visit drive-thru testing sites, and many others are unable to leave their homes to get tested for any number of reasons. This bill would allow the testers to come to you through mobile testing units and door-to-door outreach, as is safe and necessary, from members of your own community. However, if you don't want to be tested for coronavirus, you won't have to be — but you should!*

If I test positive for coronavirus, will I be forced to quarantine?

- *Absolutely not. Again, these tests would be completely voluntary. The bill does not force you or your loved ones to do anything at all. With that being said, if you or a loved one does have the coronavirus, it is advised that you do self-quarantine and maintain social distance from others. If you are experiencing symptoms, you should contact your primary care physician immediately and look into getting tested. I saw online that the bill allows the government to enter my home and remove my children if we test positive for the virus. Is that true?*
- *I've seen these alarming posts as well, but I can assure you that they are completely false. This bill does not authorize anyone to enter your home, for whatever reason, without your permission, nor does it allow the government to remove anyone from your home because of the coronavirus. Again, this bill is about providing access to testing and outreach for medically underserved communities who want/need to get tested, but currently their needs aren't being met. This bill is about helping our country safely reopen the economy so we can get back to normal!*
