From The Commission...

Do you own a house or business in Garnett? Do you have children or grandchildren in a Garnett school? Do you seek health care in Garnett? If so, a rare opportunity is upon us, an opportunity to not only catch Garnett up to today's expected level of Internet access but to also move our town/county forward toward future growth. A fiber optic company KsFiberNet is giving us the opportunity to bring high speed fiber optics to Garnett and potentially parts of the county. It's up to us to grasp this chance and its inherent benefits.

This may sound too good to be true, so what is the catch? First off, KsFiberNet does not sell Internet services to residential customers. Their primary business is fiber optics, networking, and wholesale bandwidth supply. They have planned a cable route of least resistance and greatest opportunity to reach the largest number of businesses possible within Garnett. They are currently seeking "Soft" commitments from potential business owners who have interest in business-grade Internet services.

This company has a limited amount of capital, and unlimited places to invest it. They are currently calculating the cost to put the network in the city of Garnett in order to supply high speed Internet services. This sum will represent the total infrastructure cost. In order to make this cost-effective, they need as many businesses as possible to sign up to purchase services and get them to a point of profitability. The more people sign up, the cheaper the services can be for everyone involved. They need to achieve a return on their investment for it to make sense for them. We must first get them to the break-even point, and that takes commitments and conversations.

They have not asked anyone to sign on any dotted line yet, as they do not have their costs completed.

So, how do we help? Spread the word. We need everyone to contact anyone who could benefit from this. Schools, libraries, hospitals, health care providers and government offices are their biggest target because of their high demand for data. However, any business can receive services from them as well.

To provide for residential customers, there would have to be a wholesale commitment from a local provider to purchase bandwidth and then re-sell it to end users. This is a very important piece of the puzzle as they would be a LARGE customer for the provider and offset much of the infrastructure costs. Therefore, the opportunity we have is two-fold.

First, the businesses that are sizeable enough to handle true business class service are being given the opportunity to purchase up to 100 GB service directly. This is a huge opportunity for the local businesses to enter the 21st Century with internet speeds that are required in today's business market. This sets Garnett up to be competitive in the business world. To attract new business, we need to provide Internet speeds that are currently not available.

Secondly, they would seek to sell wholesale Internet services to a local provider who would then re-sell their Internet services directly to individuals or smaller business owners who don't have the demand for their business class service. This still would take our top tier Internet availability (10/2MB) and potentially take that to 10 Gig service. That is over 1,000 times faster. Even though residents are not buying directly,

the opportunity through the re-seller makes this high-speed Internet available to them. Consequently, EVERY resident could benefit from this.

The returns to our city, and potentially the county, are greater than just the financial aspects. They include the greater benefits of narrowing the digital divide between generations, enhancing the quality of health care, providing 21st Century learning opportunities for our students, and providing services at public libraries for all citizens. Now it's up to us to avail ourselves of this opportunity; it may not come again very soon, if ever.

From The City Manager...

This article features the Garnett Community Foundation which was established in July of 2010. There are five (5) members who are entrusted with overseeing all donations and expenditures for the many projects that funds are received for. This board meets at 5:30 p.m. the first Monday of each month. Their projects have earned money to purchase equipment for the recreation center, equipment for the tot lot and supplies for the After School program.

In the beginning, the foundation accepted donations from the Goppert Foundation to help convert the armory building into the now very popular Recreation Center. Monies received were used to install a gym floor, purchase exercise equipment and install air conditioning. Over the years, individuals and community organizations have donated funds and various grants were received to purchase additional equipment that now fills the cardio room, the exercise room and the room built for YOGA, ZUMBA and SPIN classes.

The Garnett Community Foundation is a 501 (c)(3) nonprofit organization and falls under the regulations of the IRS. At the present time, the funds are managed through the Greater Kansas City Community Foundation.

People can make donations in memory or honor of someone or for a specific program. These programs include not only the recreation center, but the sports complex, general recreation programs, the Garnett Public Library, any of the parks, Cedar Valley Reservoir, the Donna Harris Memorial Park, Santa Fe Depot, Arthur Capper Memorial, Fourth Avenue Streetscape, Garnett Downtown Development/Community Network, Veteran's Banners, Garnett Area Paint Project and the new disc golf course at the North Lake.

Thousands of dollars have flowed through the Foundation to purchase the Veteran's Memorial Banners that were displayed in Garnett's downtown and along Highway 59. Because of the generosity of the Goppert Foundation, funds were given to the Garnett Community Foundation to install new windows at the

Garnett Public Library and assist the Garnett Senior Center in the demolition of two (2) buildings that made way for the construction of a new parking lot.

All donations are tax deductible and can be left at the Garnett City Hall or mailed to PO Box H; Garnett, Kansas 66032. The following levels of donations will result in the donor's name being placed on the memorial board at the Recreation Center: White-Foundation (\$100 - \$200); Bronze- Builder (\$201-\$499); Silver-Wall of Memories (\$500-\$999); Gold - Raise the Roof (\$1,000+) and Platinum - Over the Top (\$5,000+).

Donation cards are available at the Garnett City Hall and the Recreation Center. Please feel free to stop by either of these facilities to leave a donation. City staff will be glad to answer any questions you might have.

Garnett is truly blessed by the many hours given by our volunteers who serve on the various city advisory boards. They give so much of their personal time with no compensation. They volunteer because they truly believe in what they are doing and are proud of their accomplishments. My heartfelt thanks to all of them.

Notice about Your Drinking Water

The City of Garnett is required to monitor your drinking water for PESTICIDES on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During the seasonal period of May 1 - June 30, 2016, we did not monitor for BHC-GAMMA, CHLORDANE, ENDRIIN, HEPTACHLOR, HEPTACHLOR EPOXIDE, LASSO, METHOXYCHLOR, SIMZANE, TOTAL POLYCHLORINATED BIPHENYLS (PCB) AND TOXAPHENE. Therefore, we cannot be sure of the quality of our drinking water during that time. Even though this was not an emergency, as our customers, you have a right to know what happened and what we will do to correct the situation. THERE IS NOTHING YOU NEED TO DO AT THIS TIME.

The last sample was collected on May 19, 2015. The next sample will be taken during the time period of May 1, 2017 - June 30, 2017. Water plant personnel are required to do this sampling once per year during the time period indicated.

Important Information You Need to Know...

The purpose of our natural gas mains and service lines are to transport the gas to our businesses and individual homes. It is estimated that there are more than 800,000 miles of underground gas mains and service lines in the United States today. Fortunately, pipeline accidents are extremely rare, but they can occur. Natural gas is very flammable, potentially hazardous and can be explosive under certain conditions.

Garnett has approximately 44 miles of natural gas mains and 20 miles of service lines that are made up of bare steel, protected steel, polyethylene plastic and some PVC, all of which are monitored for problems and leaks.

The City invests significant time and money to maintain the quality and integrity of its gas system. Yearly we conduct a leak survey of all underground mains and service lines up to the structure's foundation wall. We odorize our gas system 24/7, 365 days a year, so that a gas leak can be detected by smell and reported. The Garnett Gas Department monitors construction and excavation activities taking place around all natural gas facilities and we prioritize and identify the areas in our system that need maintenance (also known as, "Integrity Management").

The City is responsible for the safety and security of our pipeline and pipeline facilities. To help maintain the integrity of our facilities and right-of-ways, it is important that you play a role in helping us protect against unauthorized excavations and destructive activities. Here is what you can do to help:

Be familiar with our natural gas facilities in your area. Things such as meters, regulator facilities and pipeline marker signs. Know the telephone numbers to call and keep them handy:

Garnett City Hall - **(785) 448-5496**

Anderson County Emergency Communications (Dispatch) - **(785) 448-6823**

Emergency - DIAL 9-1-1

BEFORE you dig, call Kansas One Call: **(800) DIG-SAFE** or **1-800-344-7233** OR dial **8-1-1**.

811 is a federally mandated number to get utilities located before you dig.

Again, we remind you to CALL before you DIG. It is toll-free and it is required by law. Anytime you plan projects that require digging call the Kansas One Call number or 8-1-1.

The gas department regularly communicates, plans and trains with our local emergency personnel, such as the fire department, police and police dispatchers. Upon a report of a gas leak or related incident, the proper departments can be dispatched to provide public safety assistance and to respond to the gas emergency.

Can you recognize a natural gas leak?

Answer: Trust your senses. Seeing continuous bubbling in a wet or flooded area, dead vegetation or discolored plants in an otherwise healthy environment could signal a possible gas leak. A quiet to loud hissing sound could also indicate a possible natural gas leak. In most cases, here in Garnett gas leaks are recognized using the sense of smell. Our gas system is odorized all the time so that you can detect a possible gas leak by smell.

How to report a natural gas leak:

If you think you smell natural gas inside or outside a structure, report it to the gas department as soon as possible by calling Garnett City Hall **(785) 448-5496**. If after business hours please call the Anderson County Emergency Communications (Dispatch Center) at **(785) 448-6823**. If you have a gas emergency and the gas odor is very strong and it seems to be everywhere, DO NOT OPERATE any light switches or attempt to air out the building. Exit the property, go to a neighbor and then notify the gas department by calling **9-1-1**. Wait there for emergency personnel to arrive.

Any additional gas safety related information is always free and available at Garnett City Hall.





SCAM ALERT!

Twenty years ago it was almost unheard of that untrustworthy people would take advantage of our local businesses. Unfortunately, in today's world it is a different story. We need to be protective of our records at all levels, from personal to business, both financial and confidential account information.

Below are a few tips that might help:

- Do your homework - make sure the soliciting business or individual is legitimate before donating/paying.
- Do not rely solely on someone else's reference, and don't make impulse decisions based on someone else's decisions. Do your homework.
- ALWAYS get an invoice and make sure the invoice has the business name and contact information in the event you need to contact them.
- Be leery of a demand for payment in advance or requiring cash only payment.
