NOTICE OF APPOINTMENT

You are hereby notified that **Roderick O. Ford, Esquire**, who is duly licensed as an attorney-at-law to practice before the United States Supreme Court, the federal courts, and the Supreme Court for the State of Florida, is hereby designated my Chancellor and Attorney-in-Fact for the limited purpose of working collectively and administratively with all levels of Officers and Agents of your Executive Board, Officers, Churches and Parachurch Organizations, with the objective of:

- Upbuilding the kingdom of God through teaching the Gospel of Jesus Christ in inner-city or rural African American communities (and in other communities where there are marginalized and distressed populations and both a desire and need for the Orthodox Christian faith) throughout North America;
- Establishing both formal and informal connections between the **Worldwide Anglican Church** and all other Christian Church denominations (Orthodox, Roman Catholics, Protestant, or Non-denominational) within North America;
- Establishing global missionary projects between the **Worldwide Anglican Church** and various Church denominations and community organizations throughout North America;
- Soliciting financial support for ministerial and developmental projects on behalf of the **Worldwide Anglican Church** throughout the Sub-Saharan African continent; and establishing a base of financial support among corporate donors and nongovernmental organizations;
- Coordinating visits and tours of the **Patriarch** of the **Worldwide Anglican Church** and other WAC leaders to meet with senior Clergy leaders in the North America and who are concerned about the spiritual needs and material or economic development of Africa;

- Developing interpersonal relations between the Patriarch, Archbishops, Bishops, and senior clergymen within the **Worldwide Anglican Church** and various senior leaders in Churches throughout North America and,
- Planting Anglican Churches within the African American community in particular, as well as other distressed communities where there is a desire and need for Orthodox, Bible-based Christianity.

Chancellor Roderick Ford is hereby recognized by the **Worldwide Anglican Church** as holding the honorary title of “Reverend” or “The Very Reverend”, and as such, he is deemed of being a senior clergyman of this Church, authorized to administer the Rites of the Sacraments, in his role as “Church Planter” in North America.

The organization which Chancellor Roderick Ford is hereby authorized to establish on behalf of the **Worldwide Anglican Church**, throughout North American Continent, including Canada, the United States, and the British West Indies, shall be called “**THE REVEREND ABSALOM JONES ORTHODOX ANGLICAN CHURCH – A PROVINCE OF THE WORLDWIDE ANGLICAN CHURCH, INC**” and any subsidiaries, local societies, parachurch organizations, or local Churches which may establish in the United States on behalf of the **Worldwide Anglican Church**.
