SEGMENT TWO PROVISIONS

AllSafe Driver's Ed, LLC will provide 6 hours of classroom instruction provided by a certified instructor.
 Classroom instruction shall not exceed 2 hours per day.

A minimum of 30 hours of supervised driving, including 2 hours of nighttime driving, on a Level 1 license that has been held for at least 3 continuous months must be completed before a student can be accepted into Segment 2. Supervised driving is defined as driving with a licensed parent, guardian or parent designee age 21 or older.

TERMS

Total fee is \$40 in cash. Fee will be paid on or before the first day of class by cash only. Student needs to bring their Learner's Permit the first night of class. No materials other than paper and pencil will be needed by the student; any materials given in Segment 2 are of no charge to the student. To replace a lost or damaged Certificate of Completion, the cost is \$5 payable in cash. Student needs to be here all 3 nights, there are no regular make up classes. In the event of an emergency absence, student absences will be made up when a missed class is repeated at the next available scheduled Segment 2. A satisfactory passing grade of the required State Test is 70%. This test may be taken a total of 3 times if necessary.

REFUND POLICY

If you have reserved a seat for your student and need to cancel the class, there is no cancellation fee, but please call the office as soon as possible to allow for another student to take the class. If a student does not complete the class they will be offered a partial refund of 50% if attending only 1 day. There will be no refund if they have attended 2 days; however, the student will be given the opportunity to join the next available class at no additional charge.

My student has driven the required 30 hours, at least 2 of those hours at night, since obtaining their Level 1 License.
