Old Business

Sinage at front entrance was discussed. Sheri mad a motion to purchase and place a new entrance sign as previously considered. The proposed draft will be distributed for review

The fire plug removed by EPCOR was discussed. Ed Cardenas said that EPCOR declined to replace the plug stating that "there was nothing that they could do, based on the freezing that occurs at that location." Sheri moved to have a letter sent to the NM PRC for regulatory action; Raynovch seconded the motion and it passed unanimously. Raynovich will draft a letter for Connor's signature.

New Business

TME roads, including the usage by EPCOR and residents of TM Lane and Sunnydale was discussed. Ed noted that the residents down from TM Lane have an HOA and suggested that they be included in a future meeting and correspondence.

Raynovich made a motion to invite Camilo Bustamante, County Commissioner, to the Annual meeting in June to discuss a possible roads takeover by the County. Currently, TMEPOA is subsidizing EPCOR and residents of Thunder Mountain Lane and Sunnydale, who are not officially paying for TMR roads maintenance.

Sheri suggested that a sign that states that TME residents maintain TMR roads be placed at the entrance to TME at TM Lane. (Note that the current sign at the entrance can be moved to that location when the new sign is placed.
