#### 2. PUBLIC HEARING: WA-071

Final Development Plan in a GB-S (Two-Phase) zoning district. Walkertown Landing, LLC.

Doc: I'd like to introduce from planning staff, Ellie Levina.

Ellie: On the docket this evening is WA-071. The petitioner is Walkertown Landing, LLC. They propose to build a Urgent Care at 5271 Neal Trail Drive. The request is for a Final Development Plan in a GB-S (Two-Phase) zoning district. The .49 acre site is located on the east side of Reidsville Road, between White Rd. and Walkertown Landing Drive. (Ellie's power point includes aerial views, street views from 4 directions, Area Plan map, Growth Management map and elevations) Public water & sewer are available. The site plan proposes a single access point from Neal Trail Drive. Sidewalks are proposed along Neal Trail Drive. The site is in Legacy 2030 Growth Management Area 3. In the 2014 Walkertown Area Plan Update, the proposed land use map recommends commercial land uses for the subject property. The request would allow for the development of a vacant commercially zoned site within an already developed commercial area. The request complies with all Phase One rezoning conditions of the development.

#### 6. PROJECT / MISCELLANEOUS UPDATES

Scott: Monthly Fire Report: 157 total calls, 73 Town of Walkertown, 64 northeast district. Forsyth County did establish Fire Districts and an 11 person commission.

- Sullivantown Road / Depot Street Sidewalks: WS/FC School Board approved easement request on 9/23/25 – Request for Right-of-Way certification on Depot St. Project can now be submitted. Sullivantown Road Project still needs response from Quality Oil for driveway easement.
- Harley Drive / Main Street Turn Lane Project & Ruxton Drive Sidewalk: Request for Proposals for design work being prepared.
- Traffic Study Request for Proposal of Main Street Bypass
- New Street Lot cleared and seeded. Survey complete, trees scheduled to be removed. Thanks to Todd for all the hard work clearing weeds & kudzu.

Doc: Rusty, give us a festival update.

Rusty: Our Fall Festival will be on October 18th this year.

We have 81 vendors so far. 45 Arts & Crafts, 13 Information only, 13 Direct Sales, 7 food vendors inspected by the Health Department and 5 food vendors that fall under the Agriculture Department. Quincy Lundy and the High School band will start off the festival again this year at 10:00 am. *None of the Above,* a bluegrass band from Yadkinville will start at 11:30 and *Motown Legacy Review* will start at 2:35 pm. The festival ends at 5:00 pm.

Also, we are having our first Classic Car CRUISE-IN Friday evening October 17<sup>th</sup> from 6:00 – 8:00 pm in the parking lot of the Community Meeting Building, 5145 Sullivantown Road.

#### 7. FINANCIAL STATEMENTS

Doc: We are 3 months into our year or 24% of the year.

All in line and on budget with no department over budget. Some individual lines are higher due to yearly payments. Revenue is coming in at 4%. Expenses at 13%. Current year property tax at 1%.
