AN ORDINANCE GRANTING A SPECIAL USE PERMIT TO INNSBROOK PROPERTY OWNER'S ASSOCIATION TO ALLOW A COMMUNITY RECREATIONAL COMPLEX ON 31.00 ACRES LOCATED NORTH OF HWY. F AND EAST OF SOUTH STRACK CHURCH ROAD, INNSBROOK, MISSOURI.

WHEREAS, the Zoning Code of the Village of Innsbrook authorizes the Board of Trustees to allow a community recreational complex by Special Use Permit; and

WHEREAS, an application for a Special Use Permit/Site Plan has been filed by Innsbrook Property Owner's Association for a Special Use Permit to allow a community recreational complex on 31.00 acres located north of Hwy. F and east of South Strack Church Road; and

WHEREAS, notice of public hearing to grant said Special Use Permit to Innsbrook Property Owner's Association for a community recreational complex was advertised in the Warren County Record on October 16, 2014; and

WHEREAS, the Planning and Zoning Commission of the Village of Innsbrook at their meeting of November 5, 2014, after public hearing thereon, recommended approval to the Board of Trustees for the issuance of a Special Use Permit to Innsbrook Property Owner's Association for a community recreational complex on 31.00 acres located north of Hwy. F and east of South Strack Church Road; and

WHEREAS, due notice of a public hearing on said application to be held on the 11th day of November, 2014 by the Board of Trustees of the Village of Innsbrook was duly published, held and concluded; and

WHEREAS, the Board of Trustees following said public hearing, and after due and careful consideration has concluded that the granting of a Special Use Permit to Innsbrook Property Owner's Association for a Special Use Permit to allow a community recreational complex on 31.00 acres located north of Hwy. F and east of South Strack Church Road would be in the best interest of the Village of Innsbrook.

## NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF INNSBROOK, AS FOLLOWS:

SECTION 1: The Special Use Permit heretofore granted to Innsbrook Property Owner's Association for a Special Use Permit to allow a community recreational complex on 31.00 acres located north of Hwy. F and east of South Strack Church Road Way as shown in drawings attached hereto and made a part herein and marked as Exhibit "A" is hereby granted.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and approval by the Chairman.

This Bill was passed and approved this 11th day of November, 2014, by the Board of Trustees of the Village of Innsbrook after having been read by title or in full two times prior to passage.




