## Coalition for Smarter Transportation Announces Formation & Releases Policy Principles

Mobility Providers, Municipal Governments, and Transportation Stakeholders Come Together to Educate and Promote for Smarter Transportation Policies

**WASHINGTON** — On Tuesday, the <u>Coalition for Smarter Transportation (CoaST)</u> announced its formation following a successful <u>Transportation Week 2018</u>. The Coalition for Smarter Transportation is a coalition of mobility providers, municipal governments and transportation stakeholders that have joined together to educate and promote smarter transportation policies at the federal, state and local level. In addition to advocating for smarter transportation policies, CoaST will provide technical assistance, develop materials and take other steps to help decision makers enact and implement policies that will improve our nation's transportation system.

"We are pleased to make this announcement following transportation week," **Policy Director Jason Pavluchuk** said. "Last week we join the hundreds of organizations who came together to support increased investment in our infrastructure. As part of that call, CoaST calls on decision makers at all levels to integrate innovative transportation solutions and enact policies that will leverage our investment in infrastructure by making a smarter transportation system. As a part of this announcement, CoaST issued a set of guiding principles on what "smarter transportation" means.
