

During March of this year, Mike Flanery, from Lake Julia, a BLCA and Healthy Lakes Committee Board Member, applied to the DNR for enhanced signage to educate boaters on how to protect our lakes from aquatic invasive species (AIS) like Eurasian water milfoil and zebra mussels.

All lakes are vulnerable and infestations can be started from microscopic larvae or tiny amounts of plant matter. In addition to boaters, waterfowl hunters and shoreline property owners can transfer AIS from infested waters and infect healthy waters. Recently, transferring a shore Station from an infested lake introduced zebra mussels into a healthy one. The big problem with AIS is, once waters are infected, controlling AIS is very problematic and eradicating them may be impossible. They can ruin the fun of using a lake or river.

Since several waters close by our chain of lakes (Mille Lacs, Minnetonka, Shamineau, Green, Little Elk, Sylvia, Pelican Lakes and The Crow Wing and Mississippi Rivers to name a few) are infested with AIS the BLCA Healthy Lakes Committee felt it would be prudent to educate as many people as possible on how to prevent the spread of AIS. The improved signage was seen as a good way to reach a lot of people who had the potential to spread AIS.

Flanery got a couple of new but non-current signs from the DNR. He got permission from property owners to place them in their yards next to the private accesses on the Briggs Bayou and on Big Elk Lake. His daughter Nina pounded in the stakes so Flannery could secure them. *Thanks Mike and Nina for a job well done!*

The parks and trails staff from the Sauk Rapids DNR office updated the signage at the public landings on Rush, Julia and Briggs Lakes the week of August 20th. The three signs they installed are prominently placed and very large so they should draw the attention of boaters using the accesses to the new rules and procedures required of them when they pull their boats out of our lakes, before they transport them and before they launch them.



Unfortunately, the sign for Big Elk Lake in on back order so the parks and trails staff is not certain when they will be able to install it. They plan on placing a smaller sign, soon, at the Briggs walk in access. By: Dan Merchant

Protect Minnesota's waters by following state aquatic invasive species laws

You must…

1. Clean visible aquatic plants, zebra mussels and other prohibited species from watercraft, trailers, and equipment before transporting from any water access.

2. Drain water from bilge, live well, motor, ballast tanks, and portable bait containers before leaving water accesses or shoreline property. **Keep** the drain plug out and all water-draining devices open while transporting watercraft.

3. Dump unwanted bait in the <u>trash</u>.



You may not...

- Transport aquatic plants, water, or prohibited invasive species such as zebra mussels or Eurasian watermilfoil.
- **Dump** live bait into state waters, on shore, or on the ground.
- **Launch**, or attempt to place, watercraft, trailers or equipment with aquatic plants, zebra mussels, or prohibited invasive species into any state waters.

Additional recommended precautions:

- 1. To remove or kill hard-to-see aquatic invasive species before moving to other water bodies the following is advised: **Spray** with high-pressure water and rinse with very hot water and/or
- 2. **Dry** boats and water-related equipment for at least five days

2. <u>Report</u> new sightings of aquatic invasive species. If you suspect a new infestation of an invasive plant or animal, save a specimen and report it to a <u>local natural resource office</u>.

3. Decal is no longer required on watercraft.

This 'n That

From the Flotilla event comes our 1st recipe! Thank you to Sue Merchant for sharing this delicious recipe!

From the Kitchen of: Sue Merchant	
Ingredients	Ingredients
1 Refrigerated unbaked pie crust	1 ¹ / ₂ c. Mozarella cheese
5-6 Roma tomatos (others are fine too)	1c. Loosely packed fresh Basil
4 Cloves Garlic or 1T. Powder	1/2 c. Parmesan cheese cheese
1/8 tsp. Pepper	1/2 c. Mayo (Lite)

Bake crust in 9" pie dish until brown. Sprinkle ½ c. Mozarella cheese in bottom of crust. Cut tomato in wedges. Drain on paper towels. Arrange tomato wedges in baked crust/shell. Chop finelyBasil & Garlic. Sprinkle overtomatos.

In a mixing bowl, mix remaining Mozarella cheese, Pepper, Mayo & Parmesan. Spoon over top & spread evenly. Bake 375°, 35 - 45 minutes — til golden brown.
