Annual Class Reunion a Success

50 alumnae from '74; Graduation Years Ending in 4 and 9

A record crowd attended Reunion 2009 on September 26 at SMA. There were 188 registrants and 187 in the gym, and ages ranged from 15 to 80. The five-hour event included decades reviewed, friendships renewed, and joy ballyhooed.

Mary Moriarty Mullins '49 summed it up in an E-mail sent to the school. She spent the day with her class after a 60-year separation: "The class of 1949 was represented by seven graduates. Amazing. Famous words as we met up, 'I would know you anywhere, you haven't changed'. Then we laughed. I plan to keep in touch and thank you again for a good day."

For the class of '59, it was a golden anniversary. Class chairs Maria Caputo and Ann May were relentless about making people come and their worked paid off: 35 registered. The class sat front-and-center in the gym amidst a bouquet of blue and gold balloons. In '59, those were the school colors; in 1960, they were switched to red and white.

Registrants graduated as far back as 1947 and as recently as 1999. These are the numbers per year. The biggest registration was from '74; it was 50.

Reunion 2009 began at 10:30 a.m. with registration and coffee on the main floor. The school lobby was transformed into a lounge, with photos and keepsakes hanging, baked goods covering clothed tables, and blue couches resting weary bones. The main hallway was guarded by the memorable sixfoot statue of St. Michael, towering over all as he did for decades. St. Michael looked happy too.

After coffee and catch-up, there was Mass in the church, followed by cocktails in the gym. Wine, beer, and soda were served by 20-something Erik Guzinski, a professional bartender wrapped in a red cumber bun and bow tie. He brought an easy smile and a fast pour to a very thirsty crowd.

After cocktails, Co-Principal Julia Hartman and Father Myles P. Murphy welcomed the graduates, thanking the organizers and updating all about the school. After they finished, sophomore Ivy Flores sang an a cappella rendition of Amazing Grace, causing the room to fall silent so that even the rafters could hear. Her rich soprano voice filled the space and the 187 hearts.

It was a hungry group of graduates; after Ivy sang, everyone rushed the food line. They loaded up on giant meatballs, breaded fish, potatoes drenched in butter and spices, salad,

and more (much more). They continued to eat until the desert trays were licked clean.

With stomachs filled, class photos began; reunion years ending in 4's and 9's were the focus, with artist Mike Fitelson at the lens. Most shots were taken in the cafeteria, but the class of '74 was so large that it had to be moved outdoors to the church steps. If you are

Mr. Michael Radice has come aboard as Director of Advancement and has already begun breaking records! We had our largest reunion ever on Saturday, September 26th. Mr. Radice brings a wealth of knowledge, an indomitable spirit, and a genuine interest in the future of Saint Michael Academy.

The Dean of Academics, Ms. Julia Hartman, and the Dean of Students (yours truly), are enjoying the challenge of bringing our school through this transition period. We continue pushing our students toward academic excellence while providing them with enriching activities and real-life exposure.

Academically, we have added several new elements. This year, we now have enough computer electives to ensure that students leave Saint Michael with knowledge of MSExcel,

MSWord, Power Point, web design and graphic design. We have also secured a connection with an off site AP (Advanced Placement) Chemistry class; students now receive AP credit in History, English and Science. AP courses are college-level classes taught on high school campuses. They involve significantly more challenging curriculum and more rigorous home-

work than non-AP classes, and they culminate in a high stakes exam, administered by the College Board on high school campuses in early May.

The WISE financial literacy class was introduced last year and 44 students participated. The world is becoming more financially complex and competitive, and we at Saint Michael want to ensure that our students are savvy enough to succeed.

Our relationship with McGraw Hill and The Associated Press continues again this year, providing real life business skills to many students which can not be taught in the classroom alone.

Technologically, we now have seven new SMART Boards utilized in classrooms. A SMART Board is an interactive whiteboard providing touch control of computer applications and annotation using standard Microsoft Windows applications.

Of course, it is not all about Academics, work skills and technology! We are also excited about the World Dance Fusion Club that has begun under the direction of our English Chairperson, Ms. Halima Al Tiye. A variety of other activities for the students continue, ranging from Science Clubs, to Step Dance, to the Cooking Club. Softball has been added to Basketball, Volleyball, and Track as one of our sports activities and the students are ready to play!

As always, we would like to thank you for your thoughts, prayers, and support as we continue to strive for greatness. We know that Saint Michael Academy is as special to our Alumni as it is to all of us here at the school. We know that you look back on your days here with fondness and we are committed to creating the same memories for our future graduates. God bless you and yours.

National Achievement Scholar: Senior Gabrielle Rajerison



Among the 160,000 African American students who took the PSAT, SMA senior Gabrielle Rajerison placed in the top three percent nationwide. This achievement earned her the official National Merit Scholarship Program distinction "Outstanding Participant." The gift to Rajerison is that her test scores will be sent

to colleges from coast to coast; they will court her with earnest.

But Ms. Rajerison has made her choices, and is interested in hearing "yes" only from Yale University, New York University, Sarah Lawrence College, Seton Hall University, Kenyon College, Knox College, Hamilton College, and Coe College.

As a student, Ms. Rajerison stars in and out of the classroom. Academically, she has been on the honor roll consistently from the beginning, and is a member of Honora Nagle Society. The Society accepts students who demonstrate strong academic and leadership skills. In November, she will

be inducted into National Honor Society. Her school load includes AP English, Physics, and college level history courses. Ms. Rajerison is also working toward an Advanced Regent's Diploma.

Outside of the classroom, she serves as Development Assistant for Mr. Radice, Vice President of Global Community, member of student council, and works on the prom and yearbook committees. For community service, she serves with Go Girls, providing voluntary service to area elementary schools. She also interns at St. Bridgid School and works with Operation Hush, which helps feed homeless people.

Ms. Rajerison is a native of Woodside (Queens), and a graduate of Holy Cross School in Manhattan. She is the daughter of Bakoly Razafrindralambo and Serge Rajerison, immigrants from Madagascar. Also at home are a 9 year old sister and some of her mother's relatives, including a maternal aunt, uncle, and their children. These relatives came to this country to escape political unrest in Madagascar. They want to provide hope and opportunities for their children.

Thank You to Clotilde Dillon

Mrs. Clotilde Dillon, our Principal, resigned this summer to spend more time with her family. Her husband had been ill for some time, and his condition worsened; he needed more of her help. His needs, coupled with caring for two children and working 60+ hours per week here, had become too much. She chose her family; it was a wise decision. Two veteran SMA administrators now share Mrs. Dillon's position:

Julia Hartman, Dean of Academics, and Mike Duff, Dean of Students. In the mean time, Father Myles P. Murphy is heading a search for Mrs. Dillon's replacement. He has interviewed several candidates and is looking for the right one. As soon as a new principal is hired, we will let you know.

St. Michael Academy, every year, joins 49 Catholic high schools in a quest for the perfect freshman class. Last year most of us took an enrollment hit, thanks to depleted external financial aid, scholarships, and parent wallets.

This fall, we regrouped and held a series of meetings with staff and alumnae to set goals and revise plans. The goal is to enroll 65 freshmen for next fall, which exceeds (by five)

2008-09 enrollment. To accomplish this, we will continue what works and add some elements. New things include revising principals' luncheons, adding open houses,

working with the press, and using more teachers, students, and alumnae in the process.

The fall is the height of the recruitment season. We are feverishly selling to prospective students, parents, principals, and teachers. Our activities include an organized flurry of open houses, classroom presentations, school fairs, mailings, principals' luncheons, and Shadow Days. Each is described below.

Open Houses

SMA hosts three open houses: two in the fall, one in February. The fall dates are Saturday, October 24 (1 to 4 pm) and Thursday, November 5 (6 to 7:30 pm.). The February date is the 8th from 6 to 7:30 p.m. Open houses are marketed in four ways: newspaper advertisements; media press releases: mailings to principals teachers and par

leases; mailings to principals, teachers and parish newsletters; and posting on our website and Facebook.

The October event will be traditional; November's will be unique. On October 24, prospective students and parents will begin with orientation in the library, followed by a student-led building tour. It will conclude with a club fair in the cafeteria. The Step Team will perform.

The November event will be thematic, and will include a theatrical performance unfolding through the building. The tour will commence with orientation in the cafeteria, followed by a student-led building tour. On each floor will be a performance tied to the theme, "The Promise for the Future." The "Promise" is what a SMA education can do for you. Messages will be delivered artistically. On each floor, a drama will unfold using art, music, dance, and drumming performed by students, alumnae and other professionals. Following this, guests will visit a classroom to learn about academics.

School Visits

Mrs. Nilka Rivera, Director of Admissions, will visit from 50 to 60 public and Catholic elementary schools to present about SMA to prospective students. Teachers, students, and alumnae will accompany her.

Schools in all five boroughs will be visited. During her 40-minute presentation, Mrs. Rivera will make a pitch about SMA followed by playing a game with the students. The game will take the form of SMA Bingo, where correct answers to questions result in marks on a card and a series of winners. When students get a Bingo, they win a prize.

High School Fairs

Mrs. Rivera also attends school fairs hosted by Catholic elementary schools. The schools invite admissions officers to set

up booths that can be visited by students from their school and others. Booths are staffed by school representatives, students, and alumnae; literature and take-aways are distributed. There are about 10 fairs per year.

Mailings

Each year, principals from over 300 area Catholic, charter, and public schools receive mailings from SMA. The first is an invitation to open houses; the second is a package of materials about the school; the third is an invitation to a luncheon. The magic three keeps us in the principal's eye through peak season.

Principals' Luncheons

Last spring, the first-ever luncheon for elementary school principals was held. It was a way to have one-on-one conversations with the per-

sons who steer students to high schools. Last year, 10 principals attended, and were wined and dined by SMA staff. Meals were paid-for by William Kenney, a big fan and an Advisory Board member.

This year, two luncheons will be held: October 27 and November 4. The first will offer a program: elementary school fundraising. Our guest speaker will be Tom Farrell, of Trinity Fundraising Consultants. Trinity is a national consulting firm that helps schools and churches raise funds. The November date will focus on best practices in elementary school admissions. Again, luncheons will be underwritten by Mr. Kenney.

Shadow Days

Throughout the year, SMA makes itself available for school-day visits by prospective students. These prearranged visits involve attaching an 8th grader to a current freshman, and having them walk through a typical day. The exposure helps younger students experience the school in a more personal way. Information about Shadow Days is presented at school fairs, visitations, and open houses.

How Else Can You Help SMA?

For many with limited funds, a desire lingers to help the school. Cash is needed by SMA, of course -- education does not come free. But you can help in other ways.

Volunteer Time and Talent (and Muscle)

Volunteering your time enables the school to spend more of its money and resources on educating students. It can also give you a sense of personal satisfaction and an opportunity to share your abundance.

Here are five immediate needs. If you have skill in one or more areas, please let us know. We need:

- 1. one attorney to work with the planned giving program
- 2. twelve phonathoners for the December and March phonathons
- 3. one clerical person to keep our database upto-date.
- 4. one piano tuner
- 5. unlimited window-washers

Recruit Students

Every Catholic school, large and small, faces the challenge of filling its ranks with capable, eager students. Recruitment cannot be done by the Director of Admissions alone; it is a group effort and you can help. Here is what you can do:

- 1. submit articles to your church newsletter about your experiences at SMA
- 2. talk to principals at your parish elementary school about enrolling students here
- 3. encourage your children, grandchildren, and your neighbors' children to attend SMA

Encourage Others to Give

You can organize small events to raise funds and to promote the school. You can do these in your home, a local restaurant, your parish church, or elsewhere in the neighborhood. Here are three ideas.

Hold a small dinner party in your home for 10 people and charge \$20 or more per person. Tell them you are raising money for your high school alma mater, and explain why it is important to you. In advance, call Mike Radice, SMA Director of Advancement (212-564-5346), so he can arrange for a school representative to attend and answer questions.

Sponsor a bingo night at your parish church as a fundraiser, and split the proceeds between the church and SMA.

If you are a musical artist or actor, hold a small performance for friends and family in the back room of a bar or club or in your home and charge admission. Make it clear that the money is going to SMA and explain why.
