Boulder Ridge Day Camp 2021 Pick-Up and Drop-Off Procedures

Screening Procedures

Every camper will be required to undergo screening procedures upon arrival at camp or before boarding the bus. The staff member will check the camper for observable illness (i.e. coughing, trouble breathing, excessively flushed, etc...)

In addition, the following 3 questions will be asked of each camper or their parent before they are allowed to board the bus or for camp drop off, before they exit their vehicle:

- o In the last 10 days have you been diagnosed with a confirmed or probable case of Covid 19?
- o In the last 10 days have you been in contact with any person with a confirmed or highly probable case of Covid-19 and you are not fully vaccinated or are you currently under a guarantine order from the Health Department?
- o Have you experienced any of these symptoms in the last 24 hours?
 - Shortness of Breath or Difficulty Breathing
 - Cough or respiratory distress
 - Diarrhea or vomiting
 - Sore throat
 - New loss of taste or smell
 - Unexplained muscle or body aches
 - Fatigue
 - Persistent Headache
 - A Fever of 100.4 degrees or higher

If your camper is riding with another adult please be sure that the adult conducting drop off knows the answers to these questions for your camper.

Drop Off: Before Care 7:30 – 8:45 am

Regular Camp 8:30 – 9:00 am

Pick Up: Regular Camp 3:45 – 4:15 pm

After Care 4:15 – 5:30 pm

There will be 1 entrance open for drop off and pick up which will be clearly labeled. This is the entrance farthest to the left when facing camp. Specific time slots are not being assigned for 2021.

We will be checking the ID of any person picking up. Please be sure to bring photo ID daily. If anyone other than the parents/guardians will be picking up your camper, please be sure to list them as authorized adults. To add authorized adults to your camper's profile please login on our website and go to "Authorized Grown-Ups" under Forms & Documents. Campers cannot walk home from camp.

Regular Drop-Off & Pick-Up Procedures

We will begin check-in no later than 8:30. Campers who are dropped off before 8:30 will be charged for before care. In the morning, please pull around the circle to the drop off area and wait in your vehicle to be checked in by a staff member. Campers cannot exit the vehicle until they have been checked in.

For pickup in the afternoon, enter at the same driveway, labeled pick up and drop off. A staff member will take your name once you are in line and have your campers ready to enter your vehicle by the time you reach the loading are. Please be prepared with the names of all campers you are picking up and their group numbers. Once you are in line please do not leave your vehicle or pass any other vehicles. If you need to buckle a camper you will be able to do so at the loading area.

Before & After Care Procedures

For Before Care drop-off, please escort your camper to the dining pavilion. For After Care pick-up, please enter the office and we will call for your camper.
