## SURETY/FUGITIVE RECOVERY RIGHT TO SEARCH CONSENT TO RE-INCARCERATE

I/We, the undersigned, in the event that the Defendant on the above-referenced bond fails to appear in court, or at the office of the company whenever required to do so, or if any financial statement, personal information on my part shall be found to be false or untrue, or if any of the collateral or security given shall depreciate or have become impaired, agree that the bail bond company shall have the right to surrender and/or re-arrest the Defendant.

Furthermore, I/We agree that if the Defendant fails to appear in Court or in the office of the bail bond company when requested to do so, the surety company and/or its fugitive recovery agents and/or assigns shall have the right to search my residence at any time. This document voluntarily allows the surety and its agents to search for the Defendant at my residence and arrest the Defendant if found at my/our residence. I/We voluntarily waive my/our privacy rights and hold the bonding company and its agents or assigns harmless for any property damage, even in the event that I refuse entry to my/our residence.

I/We, further understand and agree that in the event any monies due and owing 1ST OUT 24/7 BAIL BONDS in connection with the bail bond written and/or issued by them for the release of said Defendant, are not paid in the time and manner as agreed upon in writing, 1ST OUT 24/7 BAIL BONDS shall have the right to apprehend and take said Defendant into custody and surrender him/her to the custody of the authority from whom said Defendant was bailed.

In the event such re-apprehension is necessary, neither the Defendant nor the indemnitor(s) shall be entitled to return of any monies paid to 1ST OUT 24/7 BAIL BONDS for and in connection with the issuance of the said bail bond. Said monies shall be deemed liquidated damages to which 1ST OUT 24/7 BAIL BONDS is entitled, to compensate them for the costs and expenses in connection with services rendered, including but not limited to the re-apprehension of the Defendant. Re-apprehension costs shall be billed accordingly to all indemnitors at such rate in which the fugitive apprehension team shall render invoice to 1ST OUT 24/7 BAIL BONDS. This invoice will detail hourly rates, mileage, tolls, and transport fees. Other fees may be associated with recovery, and will be listed as necessary.
