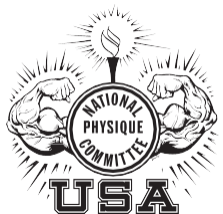
MUSIC AND ROUTINES

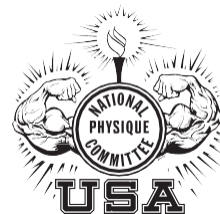

ENTRY FEES AND DEADLINES

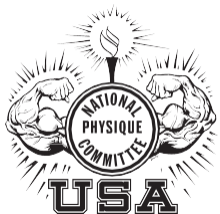
Early entry, postmarked by August 4th, 2018 is \$125 (make entry fee payable to Lenda Murray)

Entry includes access to photos provided by Stage Time Photography. Early entrants may crossover and compete in another division (i.e. Masters to Open, Figure to Fitness, etc.) for an additional \$85 each. Bodybuilding-to-Fitness/Figure/ Bikini/Physique and Bikini-to-Fitness/ Figure crossovers are not allowed. Entry fee for entries submitted after the **August 4th, 2018 postmark due date** but prior to the day of the show is \$200 and the crossover fees are an additional \$85 each. There are NO ENTRIES accepted on day of show (August 18th, 2018).

Although advanced registration is preferred, competitors will be allowed to register LATE at check- in on Friday August 17th, 2018, at the mandatory 6:00-8:00 check-in.
