WATER SAFETY ON THE LAKES

PERSONAL WATERCRAFT SAFETY AND RULES

USE SOUND JUDGMENT

Keep the neighborhood peace and quiet in mind. Talk to your neighbors. Don't modify your machine or do anything to make it louder. Steer clear of illegal drugs and alcohol.

- Personal watercraft are considered motorboats under the law so they must follow all the regulations that govern other motorboats.
- Are required to have a rules decal (provided at no charge by the DNR) in full view of the operator.
- Operators and passengers must wear a U.S. Coast Guard approved Type I, II, III, or V personal flotation device (life vest).
- Are required to carry a USCG approved fire extinguisher.
- Must travel at slow-no wake speed (5 mph or less) within 150 feet of shore (except when a PWC is launching or landing a water skier by the most direct route to open water), docks, swimmers, swimming rafts, any moored or anchored watercraft, or non-motorized watercraft.
- While towing a person on water skis or other device, must have an additional person on board to act as observer. Wide-angle rearview mirrors may be substituted for an observer but they must be factory-installed or specified by the PWC manufacturer.
- Cutoff lanyards must be properly used and attached to the person, life vest or clothing of the operator.
- May only operate between 9:30 a.m. and one hour before sunset.

AGE RESTRICTIONS FOR PERSONAL WATERCRAFT

4 It is unlawful for a PWC owner to permit its operation in violation of the age restrictions. Healthy Lakes Report

The Healthy Lakes Committee is one of six committees making up the BLCA Board and meets the first Thursday evening of each month at the Palmer Town Hall. Members include non-board members as well as board members. The focus of this committee is to protect and maintain the water quality of the chain of lakes. To do this the Healthy Lakes Committee has four areas of focus:

- 1. Water quality monitoring
- 2. Lakeshore restorations
- 3. Weed spraying

4. Septic system compliance

The Lake Report has included information on BLCA's water quality monitoring, lakeshore restoration [conservation] and weed spraying, plus information is provided on the BLCA website: wwwbriggslakechainassociation.com. Septic system compliance is a more challenging area since the BLCA, as a volunteer non-profit organization, has no legal authority or leverage to address non-complying septic systems. Sherburne Count Zoning has that authority.

Why is septic system compliance important? As you may know the Briggs Lake Chain and the Elk River are on the MPCA's [Minnesota Pollution Control Agency] "impaired waters" list because of high nutrients. Accurately identifying the sources of nutrient loading is a bit of a challenge. From our work, and close collaboration with Mark Basiletti of the Sherburne Soil and Water Conservation District, we know there are multiple sources of nutrients going into the lakes, but to date we do not have a good estimate of the contribution from septic systems.

The BLCA has invited A.W. Research Laboratories to make a presentation to the General Membership meeting on July 10 at 9:00 AM about their fly-over infra-red photography technology [Aerial Lakeshore Analysis] which helps to identify areas of nutrient loading from septic systems. The BLCA has made no commitment but is exploring this technology as an option. This is the beginning of the association's current efforts to more accurately identify nutrient loading sources so we can better target our water quality improvement efforts.

Please join us on Saturday July 10 at 9:00 AM at the Palmer Town Hall to learn more about this approach.

Shoreland Restoration Project

The first SERP shoreland restoration project planting of 2010 took place on Wednesday, June 16 at Jim and Laurian Reiners' house on Elk Lake (at the Elk River outlet). About 600 plants and sedges were installed, along with dogwood and red maple trees. Thanks to Christopher and Dominic Schiller, Doug and Susie Brown, Kenzie Phelps, Penny Houtz, Tom Koontz, Jack and Carol Kufner, and Chuck Heinemann for their help in planting. The entire cost of the plant materials will be covered under the SERP DNR Shoreland Habitat project funding! If you're cruising on Elk Lake, take a look at the completed planting.
