South Country Futurity & Derby – Rules & Regulations

- 1. <u>Futurity</u> Open to any horse which is a foal of 2012 and later (5 years & under). Horse must never have competed in any barrel race, rodeo, jackpot or other futurities before December of the previous year. Horses may have run exhibition runs.
- 2. **Derby** Open to any horse which is a foal of 2010 and later (7 years & under).
- 3. **Futurity & Derby** Photocopy of front and back of registration papers on registered horses must accompany nomination. Veterinarian affidavit (for eg. Health Paper) of year of birth and complete description of unregistered horses must accompany nomination.
- 4. Futurity and Derby will be TWO runs and average. Champions will be declared on 2 Go Average.
- 5. Running order will be drawn for the 1st go. 2nd go will run in reverse order.
- 6. Nomination payments are due **March 13, 2017** and **April 13, 2017**. Payments are to be made by TWO post dated cheques or cheque in full amount and must accompany entry forms. **Late fines will be \$50./payment.**
- 7. All cheques made payable to South Country Barrels c/o Monica Wilson Box 1378 Cardston, AB T0K 0K0
- 8. Any NSFs cheques will carry a \$25.00 Service Charge.
- 9. Substitutions will be accepted for death, illness or unsoundness. Veterinarian Affidavit of proof must accompany substitutions along with a \$25.00 fee. Substitution of rider is allowed and free provided office is notified prior to 1st go. No selling of spots.
- 10. NO REFUNDS FOR ANY REASON.
- 11. **PAYOUT FUTURTIY & DERBY:** 1st & 2nd Go 25% of Total Prize Money

Average – 50% of Total Prize Money

30 & under entries pays 4 monies in each go and average;

31-60 entries pays 6 monies in each go and average

61-80 + entries pays 8 monies in each go and average

12. RUNNINGS RULES & REGULATIONS -

- Entrants / competitors and owners will be responsible for themselves and their horses. All
 horses may be subject to a drug test, examination to meet registration identification or
 examination for age at the discretion of management. Any horse examined and found to be of
 ineligible age, failing to meet registration description or failing to pass a drug free exam will be
 disqualified.
- Inhumane treatment of horses will not be tolerated on the grounds and will result in disqualification.
- Competitors must be ready when called or they will forfeit their run.
- Completion of entry form or payment of entry fees will indicate acceptance of all rules and regulations governing this event.
- Notwithstanding anything to the contrary herein contained it is understood that each contestant / owner waives all claims against the South Country Barrel Futurity, organizing body, workers, etc. for any injury, loss of damage which may result in anyway from the operations of activities of the South Country Barrel Racing Event.
