- Can't transmit what you don't have. Quality of sobriety; not quantity.
- Concern about primary purpose and shares around drugs: my primary purpose is that I am drunk. If something runs a newcomer out the drink will drive them back in.
- Religion and spirituality: some people are staying sober without a spiritual belief. Experience
 shared of bringing a bible to a commitment and being told to leave it home. "The bible didn't keep
 you sober"; "religion is for people who don't want to go hell and spirituality is for people who have
 been there and don't want to go back."
