Bloomfield Police Department Monthly Report for September 2019

This is the monthly report for the Month of September 2019 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Sunday, October 1st at approximately 1:08am officers executed a traffic stop on Hwy 50 in the area of Eastside Road for a speeding violation. At the conclusion of the traffic stop a 30-year-old male was issued traffic citations for operating after suspension and speeding.

On Thursday, September 5th at approximately 12:50pm officers responded to a residence in the 800 block of Eau Claire Road to assist an outside agency. At the conclusion of the investigation a 31-year-old female was arrested and confined in the Walworth County Jail. A charge of bail jumping has been forwarded to the Walworth County District Attorney's office. Additionally, the female was issued a non-traffic citation for improper animal shelter-sanitation.

On Tuesday, September 17th at approximately 3:04pm officers responded to the area of Bloomfield Road near Hwy 120 for a motorcycle versus pedestrian accident. At the conclusion of the investigation a 76-year-old male was issued a traffic citation for a failure to yield violation. The 11-year-old victim was transported to an area hospital for treatment of non-life-threatening injuries sustained during the crash.

On Tuesday, September 19th at approximately 4:44pm officers executed a traffic stop in the area of Poinsetta Road and S. Lakeshore Dr. for a traffic violation. At the conclusion of the traffic stop a 42-year-old male was issued traffic citations for operating after suspension and operating a motor vehicle without insurance.

On Saturday, September 21st at approximately 1:39am officers responded to the 1700 block of N. Daisy Dr. for a hit & run property damage only crash. At the conclusion of the investigation a 21-year-old male was issued traffic citations for hit & run – property adjacent to Hwy, failure to notify police of a crash and unreasonable/imprudent speed.

On Saturday, September 21st at approximately 7:52pm officers executed a traffic stop on a go-cart in the area of Thistle Dr. in the area of Primrose Road. At the conclusion of the traffic stop a 22-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the male was issued a citation for failure to yield to an emergency vehicle.

On Sunday, September 22nd at approximately 1:31pm officers responded to a residence in the 1300 block of Hillside Blvd. for an invasion of privacy complaint. At the conclusion of the investigation a 36-year-old male was arrested and confined in the Walworth County Jail. A charge of invasion of privacy – knowingly installed surveillance equipment has been forwarded to the Walworth County District Attorney's office.

On Monday, September 23rd at approximately 4:42am officers responded to Hwy 12 in the area of Hwy B for a vehicle in the ditch. At the conclusion of the investigation a 23-year-old female was arrested and confined in the Walworth County Jail. A charge of possession of marijuana (<=500 grams) has been

forwarded to the Walworth County District Attorney's office. Additionally, the female was issued traffic citations for inattentive driving and operating a motor vehicle without a valid driver's license.

On Monday, September 23rd at approximately 1:02pm officers responded to the 1000 block of Hwy H for a warrant attempt. A 51-year-old male was arrested and confined in the Walworth County Jail for the warrant. Additionally, the male was issued non-traffic citations for possession of marijuana and possession of drug paraphernalia.

On Sunday, September 29th at approximately 8:00am officers received a bail jumping complaint which had walked into the police department lobby. At the conclusion of the investigation a charge of bail jumping was forwarded to the Walworth County District Attorney's office for a 42-year-old male who had violated his conditions of bond.

On Monday, September 30th at approximately 9:09pm officers executed a traffic stop in the area of Clover Road and Pine Road for a traffic violation. At the conclusion of the traffic stop a 28-year-old female was issued a traffic citation for operating after revocation.

During the month of September 2019, the Bloomfield Police Department responded to 804 calls for service compared to 874 calls for service during the month of September 2018. During the month of September 2019, the police department affected 168 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 140 arrests during the month of September 2018.
