#### ARE YOUR YOUTH BOWLERS & PARENTS AWARE OF THE RULES???

- 1. This tournament is certified by the United States Bowling Congress and shall be governed by USBC rules.
- 2. Competition is open to all 2020-2021 AZ State USBC Youth members. To compete, a bowler must be a regular member of a certified USBC Youth League in Arizona and not be under suspension at the time of qualifying. League substitutes are allowed to participate in this tournament if it is their only USBC Youth league USBC Collegiate members are eligible if they are 2021-2022 Youth members, bowling in an AZ USBC Youth league and have not violated USBC Rule 400.
- 3. Participants must be aware of each competition level in the state/zone and all associated rules, fees and deadlines. These items are contained in the specific state/zone rules from the State/Zone Handicap Individual Tournament.
- 4. Competition will be conducted in four divisions based on the participant's age as of Aug. 1, 2021. Participation in the wrong age division will lead to automatic disqualification. Bowlers must stay in their given division in that particular league throughout the entire window:

**DIVISIONS**: 11 & Under Boys' Handicap 12 & Above Boys' Handicap 12 & Above Girls' Handicap

#### Athletes must see these rules and choose their own Division

- 5. Competition will take place at 2 sectional sites on February 26<sup>th</sup> & 27<sup>th</sup>, 2022.

  Southern Site will be **Bowlero Tucson**: 114 S. Camino Seco, Tucson, AZ Telephone: 520-298-2311
- 6. <u>Entry closing date is February 12, 2022.</u> Tournament forms containing qualifiers' name, address, and telephone number, date of birth and Bowler Certification number and required fees must be submitted by this date to the tournament director.
- 7. The tournament format shall be:
  - 11 & Under Division will bowl 3 games on the same pair of lanes. Total pins plus applicable handicap will determine the winners of the 11 & Under Divisions from each sectional site.

#### THIS IS THE LAST LEVEL OF COMPETITION FOR AGES 11 & UNDER DIVISION.

**12 & Over Division** will bowl 4 games on the same pair of lanes. Total pins plus handicap, where applicable, will determine who will advance to the state level of competition.

Awards and Scholarship fees shall be returned 100% to the bowlers. \*Scholarships will be held in SMART Program. Account #08583. Contact person: Denise Lish, 817-385-8292

(\*USBC Rules 301 and 309 states that all scholarships must be deposited in the SMART Program.)

8. No substitutes will be permitted **once athletes have started tournament play**. However, replacements may be used for bowlers who are not present 15 minutes prior to the squad time. **Once a replacement has been made, the original bowler cannot be placed back in the tournament.** Competitors shall be allowed 10 minutes of practice time on their starting pair.

- 9. If no replacement has been made, bowlers arriving late shall begin play and the score shall count beginning with the frame then being bowled. Missed frames shall be credited with a zero. **Frames may not be made-up**. Bowlers who are not present to bowl when it's their turn will be credited with a zero for that frame.
- 10. AVERAGES: Bowlers shall use one of the following methods:
  - a. their highest current certified league average, as of February 1, 2022, of 15 games or more.
  - b. If no average with the 15-game minimum as of February 1, 2022, then a bowler's history of a 15-game average bowled closest to the date of competition may be used. If a bowler has ONLY a sport league average, then USBC Rule 202D will be used. The average adjustment chart in the USBC Rulebook will determine the "correct" average to be used.
  - c. The highest book average from 2020-2021 bowling season
  - d. If a, b, or c does not apply, Bowler will be given a 220 average for handicap average. Each league must provide an alphabetical list of their bowler's averages as of February 1, 2022, to include **ONLY** total pins, games and average. Handicap shall be 90% of the difference between the bowler's average and 220.
- 11. Only bowlers, tournament officials and center staff shall be permitted in the settee area. If needed the Tournament Director may authorize additional people in the settee area on a case-by-case basis but if only determined necessary by the Tournament Director.
- 12. Appropriate attire shall be worn and will be neat, clean, and proper fitting. Non-tattered blouses, shirts, or jerseys must have a **Butterfly Collar or a MOCK COLLAR**, it must have sleeves and be hip length if not tucked in. Nice Pants or Jeans with **NO FRAYED HEMLINES** or **SHORTS may be worn if they go past the fingertips 2 inches while standing with arms relaxed by their side. NO SPORT SHORTS, sweatpants, gym pants, or Leggings WILL BE ALLOWED).** Bowlers will not wear hats/caps (unless medically approved). Youth are to be in bowling attire when checking in and must stay in the approved attire until finish bowling. Youth participants will not wear apparel or use bowling equipment depicting alcohol, tobacco, gambling, an illegal substances, or inappropriate Language/gestures during competition (USBC Rule 301b). Athletes may not smoke or consume alcoholic beverages. The settee and concourse areas will be smoke and alcohol free. This includes E-Cigs. Smoking and alcohol consumption by non-participants will be in designated areas only. *No electronic devices will be used by bowlers while bowling in the tournament.*
- 13. Ties for 5<sup>th</sup> place will all advance to state finals.
- 14. Claims for errors in scoring or general playing rules must be made to the tournament director no later than the start of the next block or 30 minutes after the completion of competition. Questionable errors shall be decided upon by the tournament director. All other protests must be confirmed in writing to the tournament director within 72 hours of the infraction. Under this rule, each protest must be specific in itself.
- 15. Symbolic awards will be given on a ratio of 1 in 10.
- 16. Scholarships will be awarded to the first place in each of the 11 & Under Divisions from each sectional site. Additional places will be given awards if entries warrant.
- 17. Advancement from each of the sectional sites to the state level of competition will be the first 5 places in each Boys & Girls 12 & Above Divisions. In all cases at least one individual per division shall advance.
- 18. All matters not covered by these rules and regulations shall be determined by the State/Zone Handicap AZ USBC Youth Championships Tournament Committee. Tournament Committee reserves the right to accept or reject any participant.

AZ STATE FINAL LEVEL RULES & FORMAT

- 1. This tournament is certified by the United States Bowling Congress and shall be governed by USBC rules.
- 2. Advancement from league is a one-time entry. If an individual who qualified cannot participate in the state/zone competition, replacements will be eligible based on order of finish in previous competition. Replacements must be from the sectional site of the individual unable to compete.
- 3. Advancement from the sectional sites will be the first 5 places from the Northern site and the first 5 places from the Southern site from each of the 12 & Above Division Boys and 12 & Above Division Girls. In all cases at least one person per division shall advance.
- 4. Advancers out of the league level must remain in the division they qualified in during all subsequent levels. If a bowler advances out of league level in more than one state/zone, the bowler must declare one state/zone to continue competing before the next competition level. Participation in any level of competition past the league level in more than one state/zone will result in automatic disqualification.
- 5. **Entry closing date is March 12, 2022.** Tournament entry form containing qualifiers name, address, telephone number and Bowler Certification number must be submitted to the tournament director per Sectional Rule 6.
- 6. Divisions are based on the participant's age as of August 1, 2021. Competition shall be conducted in the following divisions: 12 & Above Boys Handicap, 12 & Above Girls Handicap.
- 7. **Tournament Format**: The top 20 bowler's advancement is based on the Sectional sites as stated in rule 3. Bowlers will bowl 6 games across 6 lanes, moving 1 pair right after every 2 games. All previous scores will be dropped. Handicap to be applied. Bowler's 6 game score will determine their final standing.
- 8. **Entry fee is \$35.00**. Payable at tournament site by league check, money order, cashier's check, personal checks, or cash will be accepted. If using a check or money order it must be made payable to:

#### **AZ State USBC**

A fee of \$30.00 will be assessed for all returned checks

- 9. No substitutes will be permitted **once athletes have started tournament play,** however, replacements may be used for bowlers who are not present 15 minutes prior to the squad time. **Replacements in the State Finals must be from the order of finish from the Sectional level of competition**.
- 10. If no replacement has been made, a bowlers arriving late shall begin play and the score shall count beginning with the frame then being bowled. Missed frames shall be credited with a zero. **Frames missed may not be made-up**. A bowler not present when it is their turn to bowl will be credited zero for that frame.
- 11. AVERAGES: Bowlers shall use one of the following methods:
  - a. Highest current certified league average, as of February 1, 2022, of 15 games or more.
  - b. If no average with the 15-game minimum as of February 1, 2022, then a bowler's history of a 15-game average bowled closest to the date of competition may be used. If a bowler has ONLY a sport league average, then USBC Rule 202D will be used. The average adjustment chart in the USBC Rulebook will determine the "correct" average to be used.
  - c. The highest book average from 2020-2021 bowling season
  - d. If a, b, or c does not apply, Bowler will be given a 220 average for handicap average. Each league must provide an alphabetical list of their bowler's averages as of February 1, 2022, to include **ONLY** total pins, games and average. Handicap shall be 90% of the difference between the bowler's average and 220.
- 12. Only bowlers, tournament officials and center staff shall be permitted in the settee area. If needed the Tournament Director may authorize additional people in the settee area on a case-by-case basis but if only determined necessary by the Tournament Director.

- 13. Appropriate attire shall be worn and will be neat, clean, and proper fitting. Non-tattered blouses, shirts, or ierseys must have a Butterfly Collar or a MOCK COLLAR, it must have sleeves and be hip length if not tucked in. Nice Pants or Jeans with NO FRAYED HEMLINES or SHORTS may be worn if they go past the fingertips 2 inches while standing with arms relaxed by their side. NO SPORT SHORTS, sweatpants, gym pants, or Leggings WILL BE ALLOWED). Bowlers will not wear hats/caps (unless medically approved). Youth are to be in bowling attire when checking in and must stay in the approved attire until finish bowling. Youth participants will not wear apparel or use bowling equipment depicting alcohol, tobacco, gambling, an illegal substances, or inappropriate Language/gestures during competition (USBC Rule 301b). Athletes may not smoke or consume alcoholic beverages. The settee and concourse areas will be smoke and alcohol free. This includes E-Cigs. Smoking and alcohol consumption by non-participants will be in designated areas only. No electronic devices will be used by bowlers while bowling in the tournament.
- 14. Ties will be broken by a one game roll-off. Should a tie still exist, it will be broken by an additional 9th and 10<sup>th</sup> frame roll-off, plus one/tenth of handicap per frame where applicable. (Refer to rule 326a).
- 15. Claims for errors in scoring or general playing rules must be made to the tournament director no later than 30 minutes after the completion of competition. Questionable errors shall be decided upon by the tournament director. All other protests must be confirmed in writing to the tournament director within 72 hours of the infraction. Under this rule, each protest must be specific in itself.
- 16. Symbolic Awards will be given out to the top bowlers on a ratio of 1 in 10.
- 17. Scholarships will be presented to finalists on a ratio of 1 in 10 of the Sectional Entries in each of the 12 & above divisions. The tournament director is responsible for submitting the scholarships and recipients to the SMART Program, who will administer the scholarships. Scholarships will be held in SMART Account #08583. - 18. The First Place Winners and Runner up of the 12 & Above Boys and Girls HDCP will receive paid entries into the 2022 Bowling.com Youth Open Championship in Grand Rapids, Michigan on July 15— 24, 2022, with entry fees paid by AZ State USBC Youth for Scratch and Handicap Team, Doubles, Singles, & All Events. The Arizona State USBC will provide a \$200.00 stipend to the first-place winners and runner ups to offset travel cost for the National Youth Open Tournament. Advancers will be required to be accompanied by a parent, guardian, or coach. The national finals do not provide chaperones. The stipend will be issued after participating in Grand Rapids, Michigan and upon the presentation of supporting receipts of actual expenses to the Tournament Director.
- 19. All matters not covered by these rules and regulations shall be determined by the State/Zone Handicap AZ USBC Youth Committee. Tournament Committee reserves the right to accept or reject any participant.
