# Recycling Coalition of West Virginia Committee Meeting Minutes September 8, 2022 WVDEP Headquarters

Chairman Hayes reported that the Coalition had a general operating bank balance of \$11,931 as of August 31, 2022. He also reported that the Coalition had received several donations, including Republic Services \$500, WV Cashin Recyclables\$500, Goodwill Industries of the Kanawha Valley \$500, Putnam County SWA \$500, Wood County SWA \$500, Cabell County SWA \$100 and Ohio County SWA \$100, Upshur County SWA \$200, and from the Harrison County SWA \$250.

A motion was made to accept the report as presented by Terri Tyler and was seconded by Mike Grunau, the motion was approved.

A motion was made by Kathy McKinley to reimburse Paul Hayes for two mailings containing certificates of appreciation and toolkits for the 2022 campaign he paid for with his personal debit card. Margi MacDuff seconded and the motion passed unanimously.

## **Adult Prize**

The Adult Prize Contest is going well and about 85 entries have received. The deadline is November 30, 2022, those received so far are mostly from Ohio County, good job Rebecca.

#### **ReFashion Show**

The 20<sup>th</sup> Annual ReFashion Show planning continues. Margi MacDuff offered to go on-air alongside Paul Hayes if any requests were made by local media. She also would pass along her contact details at the Huntington Herald Dispatch. Paul will see reach out to Republic Services about a packer truck tours. The dress will be delivered to the mall in September for use as display. Ads will be placed in Herald Dispatch. Judges would include Margi, Kathy and possibly Herald Dispatch. Thomas Aluise will sent out a press release calling for entries. He will not be at the ReFashion Show so someone will need to take pictures for the website. Paul will touch base with Michael Huff regarding the event and possible footage for WSAZ First at Four and including in an upcoming Environment Matters.
