TERMS AND CONDITIONS OF AGREEMENT WITH THE CIQMA

SECTION 1-DEFINITIONS:

- a) "CIQMA" means the Central Indiana Quarter Midget Association".
- b) "USAC" means the United States Automobile Club".
- c) "Applicant" means the person applying for use of a scholarship car and the acceptance into the CIQMA Scholarship Program (and all of it's benefits).
- d) "Car" means any scholarship car and anything attached to it when provided to the Applicant by the CIQMA including, but not limited to the following: engine(s), tires, wheels, components, accessories, and pit cart.
- e) "Deposit" means \$200.00 U.S. Dollars which shall be refundable subject to the Applicant's compliance with ALL Terms and Conditions of this Agreement with the CIQMA.

SECTION 2-TERMS AND CONDITIONS:

- a) Cars are to be used initially in the Rookie class and with prior approval may be used in progressive classes in accordance with CIQMA established Rookie graduation procedures.
- b) Applicant shall be responsible for repairs/regular maintenance of the Car while in their possession.
- c) Applicant shall be responsible for keeping the Car in the required condition as determined by the CIQMA and USAC while in their possession. This includes, but is not limited to all safety requirements and required decals
- d) Applicant must be able to store and transport Car to and from the track each week.
- e) Applicant must agree to bring Car to and participate in all Arrive and Drive events.
- f) Applicant must agree to participate in at least 75% of CIQMA events throughout the season. In addition, missing 3 consecutive events will terminate this agreement, the Deposit shall be forfeited to the CIQMA, and the Car shall be immediately returned to CIQMA in the same or better condition as it was received.
- g) Applicant shall be responsible for the purchase of approved and required driver safety equipment as required by the CIQMA and/or USAC, which shall include but not be limited to the following: helmet, gloves, suit, arm restraints, and neck safety equipment.
- h) Applicant must join the CIQMA and USAC as full member and comply with all membership requirements including, but not limited to paying all applicable membership fees, abiding by any codes of conduct, and complying with any other requirements necessary to remain an member in good standing.
- i) Applicant shall be responsible for all his/her applicable race sign-up or entry fees.
- j) The CIQMA reserves the right to terminate this agreement in its sole discretion, for any reason, at any time, and pursue necessary means to ensure return of all CIQMA property.
- k) Upon being accepted into the CIQMA Scholarship Program, the Applicant shall be loaned a Car and pit cart for use in any CIQMA and/or USAC race and/or events. The Car and pitcart are the sole property of the CIQMA and must be returned to the CIQMA in the same or better condition as received. The Car must be returned at CIQMA's home track located at the Indiana State Fairgrounds, on or before the CIQMA's home track closing date. THE DEPOSIT WILL NOT BE REFUNDED IF THE CAR IS NOT RETURNED TO THE CIQMA IN THE SAME OR BETTER CONDITION AS RECEIVED BY APPLICANT.
