

ORDINANCE NO. 2003-6  
AN ORDINANCE AMENDING AND CONFIRMING  
CERTAIN RATES AND CHARGES FOR THE USE OF  
AND SERVICES RENDERED BY THE  
WATERWORKS OF THE TOWN OF CLOVERDALE, INDIANA

WHEREAS, the Town of Cloverdale, Indiana ("Town") now owns and operates a municipal waterworks in accordance with the provisions of Title 8, Article 1.5 of the Indiana Code, and acts amendatory thereof and supplemental thereto, furnishing the public water supply to said Town and its inhabitants; and

WHEREAS, the Town Council of the Town ("Town Council") adopted Ordinance No. 1998-9 ("Ordinance") establishing the rates and charges for the use of and services rendered by the waterworks of the Town; and

WHEREAS, the Town has caused a rate study of the waterworks to be completed by the firm of O.W. Krohn & Associates, Certified Public Accountants, Westfield, Indiana, and based upon such rate study, the Town Council finds that certain rates and charges established by the Ordinance are insufficient to enable the Town to properly operate its waterworks plant, provide for depreciation, service its bonds, and finance additions and improvements to its waterworks system; and

WHEREAS, the Town Council finds that certain rates and charges of the waterworks should be increased and that it is necessary to amend the Ordinance and repeal the rates and charges set forth in the Ordinance to the extent they conflict with the rates and charges set forth herein; and

WHEREAS, the Town Council finds that the rates and charges set forth herein are reasonable and just, based upon the aforementioned rate study and the cost of providing service to the customers of the waterworks;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF CLOVERDALE, INDIANA, THAT:

Section 1. Section 1(a) of the Ordinance for tap in and connection charges for customers within the Town limits is hereby amended and restated as follows:

5/8" – 3/4" meter size (plus cost of meter)	\$1,000
1" and greater meter size (plus cost of meter)	\$1,000

The remaining provisions of Section 1(a) shall remain in full force and effect.

Section 2. Section 1(d) of the Ordinance is hereby amended and restated as follows:

A customer requiring a reconnection shall be charged \$75 per occurrence.

Section 3. A new Section 1(e) is hereby added to the Ordinance as follows:

Renter Deposit - \$100




Section 4. All other provisions of the Ordinance shall remain in full force and effect.

Section 5. All ordinances and provisions of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 6. This ordinance shall be in full force and effect from and after its passage and the rates and charges established here shall be effective for the first billing period following adoption of this ordinance.
