

Scobey School District
iPad/Chromebook Protection Plan

The Scobey School District recognizes that with the implementation of the iPad/Chromebook Initiative there is a need to protect the investment by both the District and the Student/Parent. The following outlines the School District Protection Plan. It is important to note that chromebooks owned by the district will not leave school grounds. It is imperative that students use their class time or study hall to finish any homework that may warrant a device.

School District Protection

The Scobey School District Protection Plan is available for students and parents to cover a single iPad/Chromebook repair or replacement in the event of theft, loss, *accidental damage*, or maintenance. The protection cost will be \$25.00 annually for each iPad/Chromebook with a maximum annual cost of \$50 per family for a single device per student. Should additional devices be checked out – each will cost \$25.00. Yearly School District Protection Plan fees will be placed into an account to self-fund iPad/Chromebook repairs and replacement. If an iPad/Chromebook is not repairable, this plan will include one replacement. If an iPad/Chromebook is damaged due to neglect, a fee of \$50.00 will be charged to replace/repair the device. A second replacement will cost the student/parent \$200. Additional replacements will cost the student/parent the full value of an iPad (approximately \$500) or Chromebook (approximately \$250.00). Parents will need to purchase this protection plan through the Scobey High School office at orientation before their student is allowed to check out an iPad/Chromebook computer. Also, students will be required to attend orientation training at Scobey Schools before they will be allowed to check out an iPad/Chromebook.

Items not covered by the Protection Plan are:

- iPad cords (\$10.00 each)**
- charging bricks/cubes (\$25.00 each)**
- iPad cases & covers (\$30.00 each)**
- Chromebook cords (\$20.00 each)**
- Chromebook covers (\$20.00 each).**

Personal Home or Homeowners Insurance Coverage

If students or parents wish to carry their own additional personal insurance to protect the iPad/Chromebook in cases of theft, loss, or accidental damage, they should consult their insurance agent for details about their personal coverage of the iPad/Chromebook computer. Most insurance companies will require a rider for electronics and only provide so much coverage and generally a higher deductible.

Additional Information

In cases of theft, vandalism, or other criminal acts, a police report, or in the case of fire, a fire report **must be filed by the student or parent** for the protection coverage to take place. A copy of the police/fire report must be provided to the school office. In the case of **intentional damage**, the student/parents are responsible for full payment. The School District Protection Plan **DOES NOT** cover intentional damage of the iPad/Chromebooks.

I will use my iPad/Chromebook in ways that are appropriate, meet Scobey School District expectations, and are educational.

I will not place decorations (such as stickers, markers, etc.) on my iPad/Chromebook or provided case; I will not deface the serial number iPad/Chromebook sticker on any iPad/Chromebook.

I understand that my iPad/Chromebook is subject to inspection at any time without notice and remains the property of the Scobey School District.

I agree to provide usernames, passwords, passcodes and other security information upon request of the Scobey School District. I will not change usernames, passwords or passcodes without Administrative approval.

I will follow the policies outlined in the *iPad/Chromebook Handbook* and the *Acceptable Use Policy* while at school, as well as outside the school day.

I will file a police report in case of theft, vandalism, and other acts covered by insurance as well as report to the Scobey School District.

I will be responsible for all damage or loss caused by neglect or abuse.

I agree to return the iPad/Chromebook, case and power cords in good working condition.

I agree to the stipulations set forth in the above documents including the iPad/Chromebook Policies, Procedures, and Information, the Acceptable Use Policy, the iPad/Chromebook Protection Plan, and the Student Pledge for iPad/Chromebook Use.
