Hopefully everyone is settling back into their routines now that January is over, and the last half of the school year has begun.

This month I'd like to question that's been coming into the office about **Professional Development funds and Remedy**. If you have a class in violation of our Collective Agreement class size and composition language, you may have chosen to receive Pro-D funds as a Remedy. Although these funds are managed by the District, our Pro-D Guidelines and Pro-D Lens should both be followed. These funds are also separate from your normal Pro-D funds, so they should be spent this school year. If you have any questions please speak to your Staff Representative or contact our office.

Another hot topic is **Maternity Leave**. It can be confusing since federal rules have changed lately. In New Westminster we have a Supplemental Employment Benefits (SEB) on Maternity leave. Basically a Maternity leave is actually both a 17 week Maternity Leave and a Parental Leave for either 35 weeks (normal parental leave) or 61 weeks (extended parental leave). Mothers may receive 95% of their salary for the first 17 weeks on Maternity Leave. Attached is a document called **Pregnancy, Parental Leave and your Benefits** (<u>http://bit.ly/2DEdafM</u>) with a lot more detail. However, the there is no substitute for doing your own research online (see attached links within the document).


