RESOLUTION NO: SL-36-2021

TITLE: ACCEPTANCE OF “AMERICAN RELIEF PLAN (ARP) – HOUSING IMPROVEMENT PLAN(HIP) FUNDING FROM THE BUREAU OF INDIAN AFFAIRS

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers of the Summit Lake Paiute Council; and

WHEREAS, in accordance with Article II, Section I (b), to represent the Summit Lake Paiute Council in negotiations with Federal, State and local governments, and other corporations, associations, partnerships or individuals, in matters of welfare, education, recreation, and social services; and

WHEREAS, the Summit Lake Paiute Council is authorized pursuant to the Articles of Association of the Summit Lake Paiute Tribe, Article II, Section I (j), to determine their own rules of procedure; and (k), to take such actions as are necessary to carry into effect any of the foregoing duties; and

WHEREAS, in the Coronavirus Response and American Relief Plan Act of 2021, H.R. 1319, Public Law 117-2, Congress appropriated funding for the Housing Improvement Plan (HIP Funds) for the purpose of addressing COVID-19 financial impacts related to coronavirus concerns as administered by the Bureau of Indian Affairs; and

WHEREAS, said funds may be used without limitation to pay for costs related to preventative maintenance, routine maintenance, operations, personnel, including employee salaries (including employees placed on administrative leave) or contracted repairs provided that all such costs are related to homeowner’s home improvement; and

WHEREAS, funding allocated in FY 2021 coronavirus response in the American Relief Act, which allocates \$64,194.00 to the Summit Lake Paiute Tribe; and

WHEREAS, funding allocated in FY 2021 HIP of 64,194.00 will be used for the following housing improvement services administered by our Housing Department:

Salaries for Implementation of HIP (15%)	\$9,630.00
Supplies needed for implementation (5%)	\$3,210.00
Eligible applicants Housing Improvements (80%)	\$51,354.00

The eligible HIP activities listed are an estimation of use/services; and

NOW THEREFORE BE IT RESOLVED, the Tribal Council of the Summit Lake Paiute Tribe does hereby submit Resolution SL-36-2021 to accept all allocated and supplemental funding allocated under the Housing Improvement Program funding appropriation.
