AN ORDINANCE REPLACING SECTION 957.01 AND 957.15 OF ARTICLE 957 OF THE CODIFIED ORDINANCES OF THE CITY OF WILLIAMSON, WHICH SHALL BE REPLACED TO READ AS FOLLOWS:

957.01 RATES.

The following rates and fees are hereby established and shall be imposed upon the users of the service of collecting and disposing of garbage, refuse and waste:

(A) Residential/Family Rates. The occupant of each residential unit, whether dwelling house or apartment, shall be considered a user and the base rate per residential unit shall be the sum of Twenty Dollars (\$20.00) per month. Each usershall purchase the service on a monthly basis. All such purchases shall be made prior to the commencement of any given period. Any resident who shall attain the age of sixty five years shall be entitled to a ten percent (10%) discount (under the residential/family rates provision only) uponsufficient proof of age by driver's license or birth certificate presented to the City Clerk of his/her authorized deputy, at the time of purchase of service, which shall be an affirmative duty of user purchaser.

Upon purchasing the service, the user shall be entitled to collection and removal of not more than three thirty-gallon containers, or the equivalent thereof, each week. Whenever the quantity of garbage, refuse or waste exceeds this amount, the Mayor and Street Commissioner are authorized to establish special rates for service to those premises, such rates to be sufficient to defray the actual costs of such service.

No refunds shall be granted to any user. In the event of relocation within the City limits, the user may transfer his/her card to the new location. In the event the user moves from the City limits, the service shall be extended to the successor in occupancy for the balance of the period for which payment was made.

- **(B)** Commercial/Business Rates. Each business location shall be considered to be a commercial user and the occupant (whether person, partnership, corporation, orotherwise) of each location shall be assessed a base fee as follows:
 - (]) Business location requiring one pickup each week- Two Hundred Forty Dollars (\$240.00) per month;
 - (2) Business location requiring two pickups each week-Three Hundred Dollars \$300.00 per month;
 - (3) Business location requiring three pickups each week-Three Hundred Seventy Five Dollars (\$375.00) per month;
 - (4) Business location requiring four pickups each week-Four Hundred Fifty Dollars (\$450.00) per month.
 - (5) Business location requiring five pickups each week-Five Hundred Twenty Five Dollars (\$525.00) per month.

DUMPSTERS

- (1) 3 yd-1 pickup per week \$100.00 per month;
- (2) 3 yd-2 pickups per week \$150.00 per month;
- (3) 3 yd-3 pickups per week \$200.00 per month;
- (4) 3 yd-4 pickups per week \$225.00 per month;
- (5) 3 yd-5 pickups per week \$275.00 per month;
- (6) 4 yd- I pickup per week \$115.00 per month;
- (7) 4 yd-2 pickups per week \$165.00 per month;
- (8) 4 yd-3 pickups per week \$215.00 per month;
- (9) 4 yd-4 pickups per week \$240.00 per month;
- (10) 4 yd-5 pickups per week \$290.00 per month;
- (11) 6 yd-I pickup per week \$150.00 per month;
- (12) 6 yd-2 pickups per week \$185.00 per month;
- (13) 6 yd-3 pickups per week \$245.00 per month;
- (14) 6 yd-3 pickups per week \$300.00 per month;
- (15) 6 yd-5 pickups per week \$350.00 per month;

A "pick up" shall be a collection and removal service procedure, which when performed by the ordinary crew members, requires a period of time not exceeding five minutes. Whenever the quantity of garbage, refuse and waste at any such location is such that a longer period of time is required to collect and remove the same, the Mayor and the Street Commissioner are authorized to establish special fees and rates for service to those locations, such fees and rates to be sufficient to defray the actual costs of such services.

Payment for commercial/business service shall continue as heretofore made (monthly - in advance).

957.15 PENALTY

Whenever any provision of this article for which no other penalty is provided, or any rule or regulation or order of the Sanitation Commissioner, after such rule or regulation or order has been approved by Council, pursuant to the provisions of this article is violated the person violating such provision, rule, regulation or order shall be fined not more than one hundred dollars (\$100.00) or imprisoned not more than thirty days or both. Each day any violation of such provisions, rule, regulation or order shall continue, it shall constitute, except where otherwise provided, a separate offense.

Whoever violates Section 957.14 shall be fined not less than fifty dollars \$50.00) nor more than one hundred dollars (\$100.00) for the first violation, and not less than one hundred dollars (\$100.00) nor more than five hundred dollars (\$500.00) for any succeeding violation. as may be ordered by the Municipal Judge.
