# **MINUTES**

The November 21, 2022 special meeting of the Innsbrook Planning and Zoning Commission was held in person as well as Zoom Video Conference, and called to order at 2:06 PM (CST) with Planning and Zoning Chairman Allen Huddleston presiding. Upon Roll Call, Commissioners Bernie Cosby, Allen Huddleston and Mike Wally were physically present, and Virgal Woolfolk was present via Zoom. After roll call, Chairman Huddleston announced that a quorum was present for the transaction of business. Also physically in attendance were Village Administrator/Clerk, Carla Ayala and Chris Graville, The Graville Law Firm.

Motioned by Commissioner Cosby, seconded by Commissioner Wally, to enter the executive session pursuant to Section 610.021(1) RSMo, relating to legal actions, causes of action, litigation and privileged communications between the Village's representatives and its legal counsel. By roll call vote, Commissioner Cosby - "Yea", Commissioner Huddleston - "Yea", Commissioner Joyce - Absent, Commissioner Rust - Absent, Commissioner Simon - Absent, Commissioner Wally - "Yea", and Commissioner Woolfolk - "Yea". With a 4 "Yea", 0 "No", 0 Abstain vote, motion passed and approved.

With a 4 "Yea", 0 "No", 0 Abstain vote, motion passed and approved. Executive session adjourned at 2:48 PM.
