An Ordinance to levy a corporate tax and special sewer assessments in the city of Garnett, Kansas, for the year

BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF GARNETT.

KANSAS.
Section 1. That a corporate tax be and the same is hereby levied on all

the taxable property in the city of Garnett, Kansas, for general revenue fund purposes, Fifteen cents on each One-Hundred Dollars valuation.

Section 2. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for street Fund purposes, Five cents on each One-Hundred Dollars valuation.

Section 3. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Water Works Bonds Sinking fund purposes, Seventeen cents on each One-Hundred Dollars valuation

Section 4. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Water works Bonds interest fund purposes, Ten cents on each One-Hundred Dollars valuation.

Section 5. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Main Sewer and Disposal works bond fund purposes, Five cents on each One-Hundred Dollars

valuation.
Section 6. That a corporate tax be and the same is hereby levied on all
the taxable property in the city of Garnett, Kansas, for main Sewer and
fund
Disposal works bond interest purposes, Six cents on each One-Hundred Dolks

lars valuation.
Section 7. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Electric Light Bond Interest Fund purposes, Four cents on each One-Hundred Dollars Valuation.

Section 8. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Electric Light fund purposes, Four cents on each One-Hundred Dollars Valuation.

Section 9. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Electric Light Bond Sinking fund purposes, Two cents on each One-Hundred Dollars Valuation.

Section 10. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Library fund purposes, Four cents on each One- Hundred Dollars valuation.

An Ordinance to lovy a corporate tax and special sever assessments in the city of Germett, Nameres for the year

Section 11. That a special assessment is hereby made on all lots and pieces of ground in sewer District number One, liable for sewer assessments for the purposes of paying One-Tenth of the original assessment, and six percent interest for one year on Seven-Tenths of the original assessment.

Section 12. That a special assessment is hereby m ade on all lots and pieces of ground in sewer District Number Two, liable for special assessments for the purpose of paying One-Tenth of the original assessment, and sixper cent interest for one year on Seven-The Tenths of the original assessment.

Section 13. That a special assessment is made hereby made on all lots and pieces of ground in sewer District Number Three, liable for special sewer assessments, for the purpose of paying One-Tenth of the original assessment, and Six per cent interest on Semen-Tenths of the original assessment, for one year.

Section 14. That this ordinance shall take effect and be in force from and after Ten days after its passage by the Commissioners, and its approval by the Mayor, of the city of Garnett, Kansas, and after its publication in the official paper, (The Evening Review.) of Garnett, Kansas.
