MAKE ALL CHECKS/MONEY ORDERS PAYABLE TO GMPC. Canadian exhibitors must make fees payable in U.S. funds. Exhibitors whose checks are returned for NSF will be assessed a \$20 service fee. Entries will not be accepted if received without signatures, fees and back of entry form with agreement. An official American Kennel Club entry form must be used. Telephone and telegraph entries cannot be accepted. No entry will be accepted which is made subject to conditions.

Bitches who come in season after the closing date will have the entry fee less \$5.00 refunded upon written certification by a licensed veterinarian to the effect that the bitch in question is in season on the day of the trial. NOTIFICATION MUST BE RECEIVED BY THE TRIAL SECRETARY BEFORE 8:00 A.M. (CDST) SATURDAY, JUNE 24, 2017

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judges, or barred from competition by action of the Trial Committee.
