Erie County has been declared eligible for FmHA Emergency Loans because of damage and losses caused by severe cold weather February 9-18, 1980 to the fruit crops, and the heavy rains September 1 through October 31, 1979 affecting the vegetable crops.

Emergency loan applications can be made through November 7, 1980 for physical losses and through February 9, 1981 for production losses.

Why not plan now to have adequate storage for your 1980 farm crops? Financing under the CCC loan program is available for buying, building, and to obtain drying and handling equipment at 10.5% interest on 85% of the net cost of the facility, with repayments to be made in 7 annual installments over an 8-year period.
