## This is the response:

"The insurance company did not specify the thickness of the mulch. They only asked that something would be put down. They seemed to have backed off of that request in the end.

The underwriter was hoping there would be a sign in the playground stating not to leave children unattended, so if something like this could be installed, great. If not, the recommendations still remain dropped."

### IX. COMMITTEE CHAIRS AND UPDATES

## A. Community Improvement and Relations – Nadia Johnson/ Don Hotard A reminder to all Lake Ramsey Pet Owners

For the safety all residents and pets please follow the Leash Laws of St Tammany Parish. Pets are an enjoyable addition to many families, and we all believe our pets are friendly. HOWEVER:

No matter how friendly, when you are walking with your dog(s) on a leash and an unleashed dog runs toward and/or jumps on you or your dog(s), there is a perception of being under attack and the leashed dog(s) will react accordingly. It can also be frightening when you are walking or riding a bike and an unleashed dog runs towards you because there is no way to know the mental state of the unleashed dog.

Restricting the free roam of dogs within our community is an absolute necessity to maintain the safety of our neighborhood.

In addition to the safety of residents who run, walk, and bike on our streets, common courtesy includes cleaning up after pets when walking them in neighbors' yards, streets, or common areas.

While this information primarily addresses dogs, residents are urged to also be considerate regarding cats that can be a nuisance if allowed to roam free.

Leash Law – Pursuant to St. Tammany Parish ordinance (see below) and the Lake Ramsey Covenants household pets shall be kept on the homeowner's property or on a leash.

- St. Tammany Parish Animal Control (985-809-0183) will come and take custody of an unleashed dog.

### Continued monitoring of dead waterfowl:

February 9<sup>th</sup> was the last report of dead waterfowl.

What are your steps as a Lake Ramsey resident:

- 1. When sick or dead wildlife is found, call 985-543-4777 (Hammond LDWF) and they will come and collect the body. They are currently testing birds for influenza.
- 2. Do not touch the animal.
- 3. Keep pets away as it can potentially be transmitted to house pets.
- 4. Report sick/dead wildlife to the board as we are keeping a log board@lakeramsey.com

### Reported Truck Incident of 2/28/25:

The incident of February 28, 2025, with the truck was nothing. We got intel through our amazing team, and we were able to see through camera surveillance, and I would like to take this moment to thank John Gross for spearheading the move to get upgraded cameras, that the truck made a u-turn, plain and simple. No one entered the exit gate.

We have an excellent team working the front gate. Don Hotard, Paul Barrios and David Caldwell are amazing!

Car incident of 3/20/25 running over traffic cone: This is an ongoing investigation. The cameras clearly caught the license plate and more. The cone is worth about \$20.00. The driver probably did not see the cone as it was low to the ground. More information will be forthcoming.

**Buoys:** Motion to buy two Buoys for pass.

Motion #1: The purchase of two "No Wake" buoys for the Pass. Expense not to exceed \$800.

Seconded: Charlotte King. All Approved.

**Motion #2:** The annual Fish Survey with Aquatic Solutions up to \$1800.

After discussion there was a vote, and it was 4-2, then one member changed their vote resulting in a 3-3 tie with no tie breaker. The reason given appeared to more related to the grass issues than McElroys qualifications for fisheries management.

Motion was tabled.

### Fertilizer Report:

Please consider using phosphate-free fertilizer this spring. Paul Palazzo at Palazzo Pest and Lawn Supply on Highway 190 can get phosphate-free/ animal and human waste-free fertilizers. He can get a bulk price. **He is looking at 15-0-15 for the ratio.** 

Also, I went to Lowe's and I saw a lot of options for fertilizer/weed and feed with that looks to be phosphate free as it has the 0 in the middle of the ratio number. I don't know what else it has in it, and I am no expert on this subject, but please be mindful of our unofficial ban on phosphates this spring.

The Carp signage was placed in high visibility areas around cameras for security. Most recently the boat launch carp sign/motion light went missing, and then the Billy Pond carp sign/motion light went missing soon after. The HOA property was recovered through tracking devices, security camera footage, and detective work. It was a resident who took the HOA property and said resident is facing charges. Stealing, removal and/or destruction of HOA property will not be tolerated.

**Guest Speaker:** Nadia Johnson emailed Carol Franze to give a talk about aquatic hitchhikers, and what we can do to stop the transport of invasive species into our lake. She is looking at her calendar for dates. Same for Spring Grass Survey.

**Nyckle App - Is working!** The lock is in, and the company has us online. Billy Abbott has been working very hard to accomplish this. Thank you, Billy.

Boat/Watercraft Stickers: Billy Abbott is working on that.

#### Lake Committee Updates

As Spring is upon us, we wanted to alert residents to the Rules and Regulations for safe usage of the

These rules were updated in December of 2024, and are posted on the website lakeramsey.com.

### A couple notable changes include item #23:

23. All watercraft should operate outside the 100-saftey boundary, and for safety reasons, should only operate within the 100-foot boundary when docking or fishing, not cruising. When watercraft is within 100 feet of shore, the watercraft shall operate at idle speed and shall move continuously past each homeowner's property. Please respect each other's privacy. Fisherman shall remain at least 50 feet from shore while troiling and fishing. Fisherman shall not oscillate (back and forth movement) past any lot or home while troiling and fishing; and shall not troil and fish past the same homeowner's property more than 2 (two) times during any given day.

#### Also notable rules

- 3. All Lake Ramsey property owners' boats, (Powered or non-powered) cances, kayaks and jet skis used in Lake Ramsey shall be registered with the HALRI, maintain liability insurance and require a Lake Ramsey Sticker to be displayed or available onboard upon request while on the lake.
- 6. All watercraft on the lake is subject to the Louisiana State Laws governing watercraft on Louisiana waters and the HALRI rules. https://www.wif.louisiana.gov/page/boating-safety. Obey all signs on the lake. All watercraft, including but not limited to jet skis or single use watercraft, must maintain liability insurance, provide evidence of same upon request, and CANNOT OPERATE WITHOUT INSURANCE ON THE LAKE.
- No person under the age of 16 shall operate a motorized watercraft unless accompanied by an adult. This includes iet skis.
- 10. No person shall operate a watercraft in a reckless or unsafe manner.
  - a. The practice of one Jet Ski attempting to spray another Jet Ski or Boat is considered extremely dangerous and reckless operation, and will not be tolerated due to safety reasons. This is a violation of Lake Rules.
  - b. Running behind a boat that is towing riders on a tube or Skis/Wakeboard to jump the waves is considered dangerous, and is a violation of Lake Rules.
  - c. Wake surfing is prohibited.
  - d. The cove is a no wake zone
- 11. All riders on Jet Skis are required to wear Coast Guard approved life jackets.

- 16. Non-motorized watercraft shall have the right of way over powered watercraft.
- For Safety reasons, All Motorized watercraft traveling in excess of idle speed or at idle speed, shall not operate closer than 100ft from shore unless fishing or docking or visiting.
- 24. No watercraft (unless disabled) shall be anchored or remain motionless within 100 ft of a homeowner's shoreline.
- 25. All watercraft traveling outside the 100 ft limit must operate in a counter-clockwise direction except when picking up a downed skier or tuber.
- 26. Homeowners with lake front property may place up to 3 buoys in the lake within the boundaries of their property. Buoys must not be placed more than 100 ft from the shoreline.
- 27. All swimmers must stay within 100 ft from shore unless accompanied by a watercraft within 25 ft of swimmer.
- 28. Placement of movable or non-movable objects in the lake is prohibited unless approved by the HALRI board. This includes underwater structure.
- 29. Filling in the lake beyond an owner's property line is prohibited.
- 30. Dumping of chemicals, fertilizers, pesticides, animal feces, etc. in the lake is prohibited unless approved by the HALRI board.
- 31. Throwing trash, cans, bottles, seafood shells, animal feces, etc. into the lake is prohibited.
